Why the Census matters for Alaska

- Determines federal funding allocations to over 70 programs
- Maintaining federal funding is critical in light of state and local budget constraints
- Organizations across the public, private, and nonprofit sectors rely on accurate census data





Reduced federal funding that compounds state and local budget gaps Lack of accurate data to plan and invest in communities across the state



Reduction in essential services like road repairs, education, etc.

Threats to an accurate count in Alaska


- Geographic barriers

- Much of Alaska requires special counting methods
- Language barriers
 - Census forms and other materials will not be translated into Alaska Native languages


- Barriers to connectivity

- 2020 Census will be the first to push online responses
- Hard-to-count populations

Mapping hard-to-count tracts



Alaska will be one of the hardest states to count in the 2020 Census.



Alaskans at risk of being undercounted



Undercount of Alaskans in special enumeration tracts in 2010 4.9%

Undercount of American Indians and Alaska Natives living on reservations/tribal lands in 2010

Also at risk: Renters, Children under the age of 5, Alaskans experiencing homelessness, Racial/ethnic minorities

How Alaskans will be counted in 2020

1. Self Response

Households receive mail prompting completion of census form online, by mail, or by phone

180,000 households in places like Anchorage, Fairbanks, and Juneau

2. Update Leave

Census enumerators deliver census materials and verify/correct addresses as they go

About 60,000 Alaska households in places like Valdez, Bethel, and Nome

How Alaskans will be counted in 2020

3. Update Enumerate

Census enumerators go door-to-door and count people at their place of residence, verifying addresses as they go

4,000 households in Southeast

4. Remote Alaska

Enumerators go door-to-door and count people at their places of residence, verifying addresses as they go

Information verified by village leader

30,000 households across Alaska

Counting remote Alaska in 2020

Timeline for Remote Alaska Operation: January 21-April 30, 2020

Count begins: Toksook Bay First wave: Western Alaska Second wave: Northern Alaska Third wave: Aleutians; Glenallen and surrounding areas

Census Bureau will hire and train enumerators in each village to conduct the doorto-door count; information will be reviewed and certified by a village leader

What statewide stakeholders can do

- Communicate the importance of the census to constituents
 - Explain what the census is
 - Highlight how the census shapes our communities
 - Emphasize that census participation is safe & confidential
- Keep up with the Alaska Census Working Group
