Honorable Representatives,

My name is John Green.

Recently we accepted an offer of judgment against the State of Alaska, Dept. of Corrections for the wrongful death of our daughter, Kellsie Green, on 1/10/2016. With the ability to release redacted evidence from video and deposition testimony that shows gross negligence on the part of the Dept. of Corrections.

In the fall after Kellsie's death, the Alaska Bureau of Investigation shared with me, a declination memo by the Office of Special Prosecution that no criminal negligence was found because they "followed their then existing medical protocols".

Through uncovered evidence that wasn't shared with investigators along with testimony from DOC employees in their own words, clear evidence shows that not only were specific protocols and/or policies NOT followed but that, they (DOC personnel) were instructed to NOT follow them. And on numerous occasions, Kellsie, along with inmates trying to help her, were refused help and threatened if they continued to ring the help button. As of today no individual(s) have been reprimanded or held accountable.

Kellsie had been addicted to heroin for about 5 years at this point. Kellsie was 24 when she died. Heroin didn't kill her. Negligence did.

Her substance abuse began after being raped at 14. The rapist was never held accountable. Despite extensive counseling, unwavering support from us and her friends, the trauma was too intense for her so, she self-medicated.

Out of desperation, on 1/5/16 we made the decision to have Kellsie arrested on an outstanding warrant. We had to plead with Troopers to arrest her.

Prior to making that decision, understand that we tried many, many times to get her help. Kellsie tried to get help herself. She didn't want to live this way. Help wasn't there. There were only 14 beds in Alaska for detoxing. **Virtually no rehabs will take you unless you are detoxed.** We couldn't call for Kellsie, she had to do it herself. Every day. If you have no phone or car and can't go or are put on a waiting list that is uncertain then, you will do whatever it takes to get another fix to stop being dopesick and hope for the next day.

My choices when Kellsie called her mom to come home on 1/5/16?

1. Let her go to her mom's house even after she had stolen a gun to hock for drug money and had stolen checks and credit cards. And risk the safety of Kellsie and her mom with the probability that the dealer would show up to bring heroin to the house.
2. Let her stay out in the sub zero weather knowing that she would either die of exposure, hook up with someone to steal to get more heroin and maybe die of an overdose or maybe make her way to a trap house where she would definitely get drugs but not for free and would have to trade something or be trafficked in order to stay.
3. Or, knowing where she was, call the Troopers and have her arrested for an outstanding warrant, let her detox in jail (**because it should be safer than a trap house**) and then, once through that process, get her into treatment that will give all of us our lives back.

Hundreds of Alaskan families are faced with this decision every day because of the lack of resources and long waiting lists for what there is. We are not the only ones who, to this day have to make these choices. Tough? That's an understatement. If you haven't had to think this way, please don't assume that you know what you would do. You don't.

Recently, I attended the funeral of a young woman who died of an overdose while on a waiting list to get help. Another Alaskan life and another Alaskan family devastated.

One would think that I would be the last person to advocate for incarceration. But, I know what a challenge it is for addicts and their families to find real-time help when they want to change their lives. We just need to change the attitude, environment and policies once they are there. DOC today just sets inmates up for failure.

### **My Thoughts**

- We don't have a crime problem. We have a drug and alcohol addiction problem that in most cases combined with mental health issues including PTSD from traumas or abuse, is the precursor for almost all criminal activity.
- Prison is where you end up after committing enough or serious enough of a crime that your time served is in years instead of days, weeks or months.
- Pretrial facilities then should be a triage to identify, early on, the reasons for why someone is in jail in the first place and to provide the correct assessment, treatment or services that will get them back on track to becoming productive citizens and good neighbors. Whether they are suffering from mental illness, addiction or are just a bad egg.
- If you do the crime you should do the time. A condition of time served needs to be an option to take advantage of **provided** rehabilitative services (including MAT) and a connection to support and services once released. It should be voluntary. If after having been given the opportunity to do the right thing and have been given all of the tools they need, if they re-offend, then there is still prison. Where, incidentally, rehabilitative services and reformatory programs (DOC MISSION & VISION STATEMENT) should continue.
- Addiction/mental illness changes the brain and removes rational thought. Yet we expect people incapable of rational thought to make rational decisions for themselves. That seems pretty irrational.
- By their own admission, DOC says that by default, it is the largest provider of drug and alcohol detoxification services.

"On any given day, DOC has about 40 inmates being monitored for withdrawal symptoms and an average of 10 per day on medically managed detox protocols,"

Recidivism rates are 66% and 75% for those between 18 and 25 years old. What we are doing isn't working.

If we are going to have a serious conversation about improving public safety, then we have to have the courage to talk about what the biggest and root threats to public safety are (substance abuse disorder and mental illness). And given the lack of resources on the outside when someone wants to change, where better to treat them than on the inside where they are literally a captive audience?

Several states have had great success through programs offered through pretrial facilities and jails with cost effective partnerships with non-profit organizations that provide treatment, peer sponsorship and assistance with case management working with parole officers. These organizations can also help with job placement/training, housing and transportation.

SB91 was with good intention and was in response to already overcrowded jails and prisons and an increasing level of crime because of the opioid epidemic. Even I was anxious for it until I realized that what would make it work, wasn't there.

**This opioid crisis affects everyone** in some way. And there are many victims of addiction. Including the families and loved ones of the addict and the addict themselves.

I hope that through your collective wisdom that you courageously make the laws, policies and changes that will have the best outcomes for all Alaskans.
