FISCAL NOTE ANALYSIS

STATE OF ALASKA 2019 LEGISLATIVE SESSION

BILL NO. HB127

Analysis

This bill creates an advanced practice permit, providing dental hygienists more autonomy to be an independent contractor, and increases the hygienist's scope of practice. The bill authorizes reimbursement for services by an insurance provider, and allows for coverage under the public assistance program through the Department of Health and Social Services.
If the bill passes, the following expenses will be incured: Services: \$3.1 (printing, postage, and legal costs for regulations project to conform with statutory changes)
Professional licensing programs within the Division of Corporations, Business and Professional Licensing are funded by Receipt Supported Services, fund source 1156 Rcpt Svcs (DGF). Licensing fees for each occupation are set per AS 08.01.065 so the total amount of revenue collected approximately equals the occupation's actual regulatory costs.
