HB 69 Repeal Alaska Public Broadcasting Commission Informational Documentation

Across Alaska, 183 rural and village communities receive emergency notifications through a satellite service, Alaska Rural Communications Service (ARCS), made available via a contract between the Department of Administration (DOA) and AT&T. These notifications include tsunami, extreme weather, and child abduction alerts. The population of the 183 communities is approximately 102,291.

Alaska Public Broadcasting, Inc. (APBI) has managed ARCS and served as the DOA's source of satellite expertise. ARCS also is used to provide a mix of public and commercial television network content.

FY19 funding for the satellite service is \$879,500 which includes the DOA/AT&T contract and some management contracts with APBI. The contract details between the State of Alaska and AT&T is internal to the DOA.

For the 3-year period from 2015 through 2018 there were <u>29 emergency alerts</u> on ARCS. ARCS alerts are sent statewide, regardless of the location of the emergency:

- 3 Tsunami Warnings
- 4 Amber Alerts
- 22 Extreme Weather Warnings

Total costs for operating the system from 2015 through 2018 was \$3,809,500. On average, each alert cost \$131,362.

Of the 183 communities, 90 have more than one alternative way of receiving emergency alerts (e.g., symmetrical broadband service, fiber optic connectivity, telephony). In addition, APBI has confirmed all 183 communities can receive emergency alerts via telephone; however, widespread distribution of the information would not occur as quickly or effectively.







AKPBC Rural Sites – Community Size




Emergency Alerts By Year
