The Dividend is designated by statute and shall be transferred.. (not be transferred based on the makeup of the legislature from year to year) or the Governor for that matter.. We need to bring back and pay back the amounts taken to protect the people's interest restoring past years fraudulent caps.

Our dividends must must be protected by a vote of the people. To protect our accounts from invalid withdraws we must have our rights represented. If our dividend is designated and then transferred by statute, any Government Draws need to be Designated for a draw with a user fee equivalent to what was charged to the people during the last three years. A user fee for government services must be assessed to balance out draws from the earnings and to correct additional earnings affected by these caps.

The legislature shall not monopolize our DIvidend or take draws for special interest without a vote of the people. Draws for government must never to exceed 50% of earnings from year to year. The last 3 years funds were taken but not spent on government. This is a legislative attempt to steal from the peoples portion of the Dividend still held in reserve as of today.

Transferred amounts should follow the same rules that have been in place prior to 2016 to restore our portion of the funds earnings. Based on dividends reduced to half or more the last three years.. We request a user fee be charged of 50% on any draws requested over the next three years to be charged by the PFD Corporation. These protections and any legal issues representing the people must protect the peoples rights and should be funded by the Corporation of the Permanent fund as an insurance policy for our share of the 50% that We the People stake-holders own to protect our half of the earnings with consistency and future constitutional protections.

There also may be federal tax implications for the state monopolizing the private portion of this fund. Federal taxes are paid on an individual basis and it may be considered fraud/waste and abuse by the state for not paying a full dividend in past years. Individuals pay taxes and the state would have to make up the difference between what was taken and any interest earned fraudulently.
