RE: **Residency Requirements for Voters and Permanent Fund Dividend and Longevity Bonus Recipients**  
Research Request 97.025

You asked for a review of the residency requirements for Alaskan voters and permanent fund and longevity bonus recipients. Specifically, you requested information about changes to the residency requirements since they were first enacted. After a brief summary, this memorandum defines residency, and then reviews the specific requirements for voters and permanent fund and longevity bonus recipients.

### Summary

Alaska's constitution originally required voters to maintain a residency of one year in the state and 30 days in a specific voting district. In 1972, a superior court decision prompted legislators to amend the constitution, requiring voters to be 30-day residents of both the state and a voting district (*State v. Van Dort*, 1972). To reward longtime state residents, lawmakers included provisions in both the permanent fund dividend and longevity bonus programs that linked benefit payments to an individual's length of residency. In 1982, the U.S. supreme court found that linking payments to a duration of residency is unconstitutional (*Zobel v. Williams*, 1982). As a result of the *Zobel* decision, lawmakers changed the permanent fund dividend's residency requirements to allow payments to all Alaskans who had lived in the state for six months. In 1984, due to a court case questioning the constitutionality of the longevity bonus program's residency requirements (*Schafer v. Vest*, 1984), lawmakers removed provisions that tied benefit entitlement to a duration of residency. Legislators changed both programs in 1989, instituting a two-year residency. This residency requirement was subsequently found unconstitutional, and a one-year provision replaced it. The current residency requirement for both programs remains one year.

## **Residency**

Alaska Statute 01.10.055 defines residency as being physically present in Alaska with the intent to make a home and remain in the state indefinitely. A person proves intent by maintaining a principal abode in Alaska for 30 days, and by making no claims of residency in other states. According to Deborah Behr, Assistant Attorney General, AS 01.10.055 is the default definition of residency in Alaska's regulations, however, other statutes have expanded upon it as necessary. Attachment A includes a table, prepared in 1992, of statutory residency requirements.

### **Residency Requirements for Voters**

Originally, Alaska's constitution required voters to be one-year residents in the state and 30-day residents in a specific voting district. In 1972, a superior court decision found that the state could not justify a residency requirement greater than 30 days.<sup>1</sup> Lawmakers amended the constitution to reflect the court's decision.<sup>2</sup> The superior court's judgment is consistent with a 1973 U.S. supreme court decision that supported a 50-day durational residency requirement, although the supreme court found this requirement pressed the limits of constitutionality.<sup>3</sup> Currently, voters in Alaska must be 30-day residents of the state and of a specific voting district before participating in an election (AS 15.05.010).

### **Residency Requirements for Permanent Fund Dividend Recipients**

Upon enactment in 1980, the permanent fund dividend program allowed payments to Alaskans who were 18 years or older and had lived in the state all or part of the benefit year. The state calculated each payment amount based on an individual's length of Alaska residency. In 1982, the U.S. supreme court found that calculating payments based on a graduated scale of residency is unconstitutional.<sup>4</sup> Responding to the court's decision, lawmakers passed legislation that allowed equal payments to all individuals, including children, who were Alaska residents for at least six months before submitting applications.

In 1987, lawmakers made minor changes to this requirement, mandating that individuals be continuous residents for six months immediately preceding April 1st of the current dividend year.

In 1989, legislators responded to concerns created by the transient nature of Alaska's many seasonal workers and strengthened the residency provisions, requiring individuals to be residents for 24 months before becoming eligible for payment.<sup>5</sup> A superior court ruling in 1990 found the 24-month provision unconstitutional, and an alternate one-year requirement went into effect.<sup>6</sup> The current residency requirement remains one year.

Additional residency requirements affect individuals who are temporarily outside the state but intend on returning. In 1980, absences were acceptable for several reasons including post-secondary education, military duty, medical treatment, and Congressional service. Lawmakers amended the provisions in 1988, allowing absences for high school students, and requiring residents temporarily living outside the state to be physically present in Alaska at least once every two years.<sup>7</sup>

### **Longevity Bonus Beneficiaries**

A predecessor of the Alaska Longevity Bonus (ALB) can be traced back to 1915. In that year, the territorial legislature authorized a monthly allowance of \$12.50 for needy, elderly Alaskans who chose not to enter the newly created pioneers' homes.<sup>8</sup> Lawmakers established the current ALB program in 1972, requiring beneficiaries to be residents on or before statehood, have a minimum of 25 years residency in Alaska, and be at least 65 years of age. Except for benefit increases, the program remained unchanged for twelve years.

In 1984, legislators responded to a pending lawsuit which questioned the constitutionality of ALB regulations by changing the residency requirement to one year and removing the pre-statehood provision.<sup>9</sup> The state pursued this course of action because the original ALB legislation contained language that terminated the entire program if any of its provisions were invalidated.

In 1989, lawmakers changed the residency requirements to two years for ALB and the permanent fund dividend. As previously mentioned, the two-year residency requirement was found

unconstitutional and replaced by a one-year provision. The one-year residency requirement remains unchanged.
