Administrative Costs in the UA System



The current plan agreed upon by the Board of Regents and the Governor to cut an additional 45 million in annual state funding will negatively impact educational opportunities in our state however that cut is administered. But if there are to be such cuts, it makes sense to prioritize cuts to administrative costs rather than academics, research, or student services.

After all, promoting learning, inquiry, and creative activity are the primary functions of higher education.

Moreover, tuition dollars from instruction and grant funding from research are primary sources of revenue for the universities. So, cuts to research and instruction will be counterproductive.

Most of all, administrative costs in the UA system are high compared to other systems, while instructional costs are not.



It is commonly assumed that centralizing administration at UA is the best way to reduce administrative costs. Today, I plan to provide evidence for why this is not the case.

To better understand cost drivers in the UA system, I have analyzed FY17 expenditures at the UA System and compared them to peer University Systems using data from The Integrated

Postsecondary Education Data System at the National Center for Education Statistics.² This comparative information not only calls into question the idea that more centralized administration is more cost effective, but also provides the basis for an alternative approach that cuts administrative costs where they are comparatively high: the Statewide System Office.

To conduct my analysis I compiled data about all institutions within each system, including universities and their system offices. Most system offices report separate data to IPEDS. I used other reports to document expenditures at some system offices.


[Methodological Note: This analysis compares costs of system offices, the universities they serve, and the combined costs making up total system expenditures. While all systems report using the same NCHEMS categories of expenditures, interpretations may vary. Some system offices count expenditures that simply pass through the system office or that are used to support programs not directly part of the university system. Since the focus of this analysis is the cost of administration, various non-administrative expenditures of system offices have not been counted. For this reason, what is identified as "total system expenditures" doesn't include everything. It consists in the total expenditures of each university and the *administrative costs* of the system office. So, for example, physical plant expenditures at the UA Statewide Office are not included in the calculation of system office or system expenditures at UA.]

Besides UA's 19 peer systems, I have run the same analysis for system office expenditures of 18 other public university systems using IPEDS data, enabling a comparison between the UA system and 36 other public systems. Besides the UA system, nine of these systems have total system expenditures under 1.32BN. With average total expenditures on par with the UA system budget, these systems averaged 12.1M on administrative costs at their system offices and with the exception of the North Texas System, all had administrative expenditures less than 12.1 M. Now consider that administrative costs at UA Statewide were 48.8M in FY18, quadruple the average.

I expect the reply that Alaska is different and, of course, it is. Many of these smaller systems do not have the geographic scope or as many extension campuses as the UA system does, though many have more students and administer as many or more separately accredited institutions.

Per FTE Student



And the fact that instructional costs in the UA System are on par with instructional costs per full-time equivalent (FTE) student at peer systems, suggests that one of Alaska's distinctions need not include administrative costs twice the average expenditure per FTE student than its peer systems.

UA Administrative Expenditures are compared per unit with average peer rates of spending on administration.

An examination of administrative costs at UAF, UAA, and UAS also supports the idea that the high administrative cost in the system may not be accounted for by the standard "but Alaska's different rebuttal." Each of these universities has its own peer institutions, just as the UA System has peer systems. Some of these institutions belong to systems, which share administrative costs. The average administrative costs relative to total institutional costs at these peer institutions provides a benchmark for administrative costs at UAF, UAA, and UAS, (9.1%, 10.8%, and 12.0% of total expenditures, respectively). When applied to each respective UA university's total expenditures, this shows rates of spending at the universities to not be considerably greater or less than their peer institutions in systems. By contrast, the UA Statewide Office appears to be an extreme outlier.



Peer averages for UAF, UAA, and UAS reflects the average portion of expenditures devoted to Institutional Support at peers in systems only. Peer Institutions were identified as belonging to systems if they shared a governing board with another accredited institution. And the fact that FY18 administrative expenditures at the UA Statewide Office exceeded the average for System Offices at Peer Systems by 220% should, in my opinion, lead the Board of Regents and the legislature to ask more questions and actively explore options that so far have not been carefully considered. And the fact that the UA System ranks at the top of peer systems for administrative spending as a system and at its system office, should, I think, prompt further questions.

[Note: As indicated on Slide 7, there is a discrepancy between the summary of administrative costs represented in IPEDS as compared to other official UA reports, including the UA in Review Reports and the UA Yellowbooks. The FY17 IPEDS data does not account for 22.7M in Institutional Support costs in the UA system.]

Key Findings of Systems Review

- The UA System has high administrative costs and high system office costs compared to other systems.
- The data shows no positive correlation between increased centralization of administrative expenditures and increased administrative cost efficiency.
- Instead, there is a moderate positive correlation between greater centralization of administrative expenditures and greater administrative cost per student (r=0.77 for peer systems, r=0.48 for small systems, and r=0.57 for all public systems).
- And there is a strong positive correlation between high costs at system offices and high spending per student on administrative costs in systems.
- Administrative costs are not on average higher in smaller systems or their system offices.

Is reinforcing the System Office by consolidating university operations likely to bring about greater savings? Correlations between centralization of administration and cost of administration at peer systems does not support such an assumption, since at peer institutions there is a strong to moderate correlation between centralization and higher administrative costs. Given that the UA System is already twice as centralized as the average system peer, one wonders if it is time to explore some other options.

Despite these facts, this July following the system president's recommendation, the UA Board of Regents, has directed the consolidation of university operations, which further reinforces the cost of the system administration. Last summer the university HR departments were consolidated under the system HR department. The same is currently underway with University Development, Procurement, and IT with plans for similar consolidations of other non-academic functions.

Unfortunately, these consolidations already appear to not be generating the savings originally promised in July.

At the Board of Regents meeting in July, the system president included a slide showing a 17% cost reduction from the consolidation of the university HR departments under the system HR

department. However, paperwork filed this September with the FY20 Distribution Principles identifies only a 7.53% reduction in expenditures. ¹⁰

At the July meeting, the consolidation of HR was presented to the regents as a "prototype" for the consolidation of other non-academic functions and it was at that meeting that they passed a sweeping motion authorizing the system president to proceed with the immediate "consolidation and standardization of processes in "back office" functional areas." Despite the fact that the stated purpose of these consolidations was to reduce administrative costs, it was explained by the system president a month later that while plans to consolidate University Development under the system office were moving forward, no annual cost savings was projected for this area of consolidation.

Consolidation of these operations under the system office potentially pose problems for accreditation. According to NWCCU standards, each accredited institution is supposed to have a CEO who is "accountable for the operations of the institution" with "full-time responsibility" for that institution [2.A.7 and 2.A.10]. ¹¹ The university chancellors cannot be "accountable for the operations of the institution" if those operations are not under their control.

A wholesale centralization of non-academic functions is also a mistake because in many cases it is likely to render these functions less efficient or effective in the delivery of services. No evidence has been provided for improved delivery of service under the new HR restructure and anecdotes paint a picture of a department in disarray with uncharacteristically long delays.

Of even greater concern is the centralization of the universities' development offices, which are not back offices, but the front-facing fund-raising arm of each university. Effective fund-raising depends upon organic relationships between faculty, alumni, and partnering entities. A remotely controlled development office that lacks the organic connections in each regional community has not succeeded and further reinforcing this approach through greater centralization won't work.

The approach recommended by the system administration and adopted by the Board reinforces and in fact, rewards the most administratively inefficient unit in the system

As long as the Statewide system office controls the information flow to the regents from the universities, the regents will not receive good information about ways to reduce administrative costs that target the Statewide Office. And as long as the chancellors do not have the ability to negotiate shared service agreements with Statewide or among themselves or even within their respective communities, the long term effect will be that administrative costs at the Statewide office will remain high.

Consider the process by which the decision was made this July to consolidate all non-academic functions at UAF, UAA, and UAS.

- No cost benefit analysis was completed.
- Alternative ways to reduce costs in these areas were not developed or discussed.
- The university chancellors were not consulted or asked to offer alternative plans for how to more efficiently run these operations which were previously under their control.
- And there was misinformation about the savings associated with these consolidations.

This failure in the deliberative process is symptomatic of a failure in our structure of governance.

If our focus is on long term financial reform, we cannot ignore the structural problems of governance and distribution of authority that lie at their root. The Board simply cannot perform its due diligence without accurate, well-researched information and that information has been proven to be elusive as long as the chancellors' appropriate sphere of authority over the operations of their institutions are not enshrined in board policy and respected by the system president.

There are two kinds of centralization: centralization of authority and centralization of operations. The UA system currently suffers from the excesses of both. While the focus of my presentation has been on the centralization of operations and the associated costs to the system as a whole, it is the matter of proper distribution of authority that has even greater urgency. Centralizing authority has undermined a reliable evidence-based decision making process for vetting alternative operational models.

How could a proper distribution of authority and improvement of the deliberation at UA be achieved? I close with what I consider to be some important first steps:

- Board policy should be adopted acknowledging the institutional authority of the chancellors as true CEOs of their institutions with authority over university operations.
- If that does not occur, legislation could be passed delineating the chancellors' authority and relation to the Board.
- In addition, legislation should be passed improving board governance through the creation of a faculty and a staff regent position on the Board of Regents. 12
