As a resident of the Abbott Loop/Independence Park neighborhood, I am writing to you today to express my deep concern about how climate change will affect myself, my family, and our entire state moving forward. The main purpose of my message is to express my support for House Resolution 12. I hope you will consider the future of our beautiful state and vote to support the resolution.

Climate change is impacting Alaska 2-3 times the rate of the lower 48. Many of my friends rely on harvesting salmon to make a living, yet increased glacial runoff causes changes in the temperature and salinity of rivers and streams that our salmon need to thrive.

The increase in atmospheric temperatures, leading to an increased prevalence of invasive species in the state, is also concerning to me, as in previous work in invasive species management in Denali National Park, I saw firsthand how invasive plants can take over land that had previously served as important habitat for native insects and animals.

As the only Arctic state in the nation, Alaska is positioned to be an active voice in international discourse relating to climate change and adaptation policies, independent of the federal government. I urge you to support House Resolution 12 and allow Alaska's House Representatives to take an active role fighting the climate emergency.

To the Resource Committee Co-chairs,

Thank you for leading the effort to create a house special committee on climate change through HR 12. I am a Chugiak resident who moved to Alaska almost a decade ago, to earn a PhD in biology from UAF because I was concerned about the potential effects of climate change on Arctic wildlife. Despite my background, the pace of warming-driven changes to Alaskan landscapes still takes me by surprise. On my first trip to the state, I visited the cliff-side auklet colonies on St. Lawrence Island, where thousands of birds screamed through the air at all hours of the day. I read recently that those colonies have gone silent, as massive seabird die-offs linked to warming ocean temperatures have shown up all over the state. Meanwhile, Savoonga residents who gave me my first taste of walrus struggle to feed their families without a stable sea ice platform from which to hunt. At the same time, the smoky summer of 2019 was a stark reminder that Anchorage and the Mat Su valley are not immune to the hazards of continued warming.

Alaska cannot afford to ignore the risks of a warming climate, and HR12 is an important step towards preparing our state for the future. However, I wish the bill more explicitly recognized that human emissions are driving the current warming trend. We need to emphasize our ability to create a better future through reduced emissions, to keep people from feeling overwhelmed or hopeless in the face of the climate crisis. Although Alaska may contribute a small fraction of US emissions, as a major oil producing state we are in a unique position to influence the actions of the oil and gas industry. We are also blessed with an incredible diversity of renewable energy resources, including ground-breaking microgrid systems based on tidal energy, and pursuing these resources could create jobs, foster innovation, and provide cheaper, more stable energy production in Alaskan communities. This means that we have both the opportunity and the responsibility to lead the way on the path to lower carbon emissions.

Thank you for showing leadership on this issue. I have already asked my representative, Cathy Tilton, to support HR 12, and I have been telling everyone who will listen to contact their representatives as well. If there is anything else I can do to support the bill, please let me know.
