
Between sea duty tours, Rear Admiral Bell specialized in operations management. He served tours of duty as Administration Officer at Coast Guard Group New Orleans,

Jason Suslavich is the Director of National Security Policy and Senior Advisor to U.S. Senator Dan Sullivan (Alaska). Mr. Suslavich joined Senator Sullivan's staff in February 2015 and manages the Senator's Senate Armed Services Committee assignment, including the Senator's current chairmanship of the Subcommittee of Readiness and Management Support. Senator Sullivan is also a member of the Commerce Committee – chairing the Subcommittee on Security – the Environment and Public Works Committee, and the Veterans Affairs Committee

Mr. Suslavich has worked on Capitol Hill since 2005 for Members including the current Dean of the U.S. House of Representatives, Congressman Don Young (AK-ATL), the former Speaker of the House, Speaker J. Dennis Hastert, and the current Chief Deputy Whip, Congressman Patrick McHenry (NC-10).
