FISCAL NOTE ANALYSIS

STATE OF ALASKA 2020 LEGISLATIVE SESSION

Analysis

This legislation amends the criminal offenses related to sex trafficking, human trafficking, and creates a new offense of being a patron of a sex trafficking victim. This bill will apply to juvenile offenders under the jurisdiction of the Divsion of Juvenile Justice. Certain juvenile offenders may be waived to the adult correctional system under AS 47.12.030 and AS 47.12.100 for these offenses.
The bill will have no fiscal or programmatic impact on the Department of Health and Social Services, Division of Juvenile Justice.
