## STATE OF ALASKA 2020 LEGISLATIVE SESSION

# **Analysis**

This legislation streamlines the licensure and regulation of nurses by permitting Alaska to join a comprehensive national organization that provides for a multistate license with uniform qualifications and practice expectations. This legislation will reduce barriers to licensure, enhance license mobility, and increase opportunities for nurses to practice in Alaska.
The Division of Corporations, Business, and Professional Licensing will require \$18.4 to cover legal costs to amend regulations, printing, and postage in the first year. The National Council of State Boards of Nursing will reimburse the total cost of the regulations project through grant funding. The Department of Commerce, Community, and Economic Development requests statutory designated program receipt (SDPR) authority in order to receive these funds.
Professional licensing programs within the Division of Corporations, Business and Professional Licensing are funded by Receipt Supported Services (fund source 1156 Rcpt Svcs (DGF)). Licensing fees for each occupation are set per AS 08.01.065. The total amount of revenue collected approximately equals the occupation's actual regulatory costs. The division receives no UGF funding.
