FOR AN ACT ENTITLED

- "An Act raising the minimum age to purchase, sell, exchange, or possess a product
 containing nicotine or an electronic smoking product; and providing for an effective
 date."
 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:
- 5 * **Section 1.** AS 11.76.100(a) is amended to read:
- 6 (a) A person commits the offense of selling or giving tobacco to a **person**7 **under 21 years of age** [MINOR] if the person
- 8 (1) negligently sells a cigarette, a cigar, tobacco, or a product containing tobacco to a person under **21** [19] years of age;
- 10 (2) is <u>21</u> [19] years of age or older and negligently exchanges or gives 11 a cigarette, a cigar, tobacco, or a product containing tobacco to a person under <u>21</u> [19] 12 years of age;
