On Friday, February 28th the Department of Fish & Game (DF&G) presented to the Senate Resources Committee Senate Bill 189 which establishes the sport fish enhancement surcharge. Enclosed you will find an amended sport fishing license surcharge breakdown and a memo from the Department of Law regarding dedicated funds. There were several other questions provided following the hearing. Please see answers below.

Q: Can the department provide a list of all state-owned hatcheries and the maintenance needs of each?

A: The state still owns 11 hatchery facilities around the state from when the Fisheries Rehabilitation and Enhancement Division still existed under the Division of Commercial Fisheries (Table 1). All but one are leased to private non-profit (PNP) operators at no cost to the state. The legacy facility on the list, Crystal Lake in southeast Alaska, and the two new Sport Fish hatcheries (William Jack Hernandez in Anchorage and Ruth Burnett in Fairbanks) are the only facilities specifically designated as "sport fish hatchery" facilities. There are also 3 other legacy Sport Fish hatcheries that still serve a purpose as part of the sport fisheries enhancement program (Fort Rich, Elmendorf and Crooked Creek).

Q: What are the priority maintenance needs of each?

A: In the stocking FAQ provided by the Division of Sport Fish there is a more exhaustive list of maintenance needs however, the following items are the priorities for each:

- Raceway rehabilitation at Crystal Lake Hatchery
- Upgrades to water discharge system, egg-take work area and visitor viewing platform at the William Jack Hernandez Sport Fish Hatchery
- A third back-up well at the Ruth Burnett Sport Fish Hatchery

Q: Can the department further define the term "sport fishing facilities".

A: There is no formal definition in Alaska's statutes or regulations. However, a fish hatchery is an establishment in which young fish are produced and reared especially for later release in natural waters. Therefore, a "sport fish hatchery" would be a hatchery that produces and rears young fish for later release into natural water for the primary benefit of sport fishing.

Q: Are there other facilities around the state where these funds could be expended?

A: The Division of Sport Fish currently uses \$0.5M of the surcharge funds to augment production and rearing of Chinook salmon for release into saltwater around important sport fisheries in Southeast Alaska. Contractual agreements are in place with private-non-profit (PNP) hatchery operators to do this activity for the division to increase sport fishing opportunities across the region. As mentioned above, the division still continues to use the older hatchery facilities to perform some functions necessary to the overall program and maintenance needs at those still exist. For example, Crooked Creek plays an important role for collecting brood stock and egg-takes. The division also uses other funds to pay for salmon production in Kodiak through a cooperative agreement with Kodiak Regional Aquaculture Association.
