Analysis

HB 257 adds banks to a list of business activities that are exempt from business license requirements. The impact to the Division of Corporations, Business, and Professional Licensing is nominal, with only 33 business that currently fall under the "Bank" North American Industry Classification System (NAICS) code.
The Division of Corporations, Business, and Professional Licensing does not anticipate fiscal impact from this legislation.
The Business Licensing section of the Division of Corporations, Business, and Professional Licensing is funded by General Fund/Program Receipts fund source 1005 GF/Prgm (DGF). Business licensing fees are set per AS 43.70, and revenue in excess of authorized budgeted expenses reverts to the State of Alaska general fund.
