The first question I would like to pose is: What is the best way to respond to the current emergency given our conservative fiscal approach? How can we get the most "bang for our buck" by helping those in the need, quickly and efficiently? What is the current emergency likely to cost us?

The answer to the first question is found in the attachment which I call the Graduated Dividend. It is a one half statutory dividend (1 billion) distributed on the basis of household income. It was created by applying an income tax to the Dividend, without creating a new income tax law.

The answer to the second question, I have not fully fleshed out. It would require using existing infra structure and obtaining the information from those who have been impacted by the lay offs from Gov't closures of businesses. That need is said to be 20,000 individual employees in Anchorage alone.

The last question must suppose information about the length of the emergency and the progress of the virus. The latest realistic estimate I have seen is that we should know in 8 weeks whether we are out of the woods or not. We have seen a very significant decrease in cases in both China and S. Korea. This means the disease can be contained. What the cost will be in terms of dollars to the State of Alaska....depends on the amount of time businesses are shut down and people are laid off. The State must assume responsibility for the action it takes in controlling the virus. And there will be other losses in Revenue due to the pandemic. So, consider well in coming up with an estimate of what fighting the virus is going to cost.

My name is Michael Jeffery, a 43+ year resident of Utqiagvik/Barrow, Alaska. I have the experience of being a retired Superior Court Judge, but I am making these comments personally. Our state and nation are going through especially challenging times. I appreciate your dedication and willingness to grapple with these issues, balancing effectively the financial realities with the increasing difficulties faced by Alaskans. I am willing to pay broad-based taxes to help provide funds for these important programs.

I support continued funding for the following:

- 1. Public Broadcasting. KBRW is our local radio station and is a critical part of our lives—especially now. It serves an area the size of Minnesota, and carries a broad mix of programming including international/state/local news, native cultural events, programs of our faith communities, local public meetings and the daily calendar. There activities are especially important as most people must stay at home due to COVID-19. Public television is also an important link to the greater world with unbiased news reporting, cultural program and documentaries and mystery shows.
- 2. Reentry Services in the Department of Corrections and associated agencies. Such activities are not only humane, but they are tremendously cost-effective to reduce the high rate of returning citizens who end up back in jail.
- 3. Therapeutic Courts. These programs have proved themselves nationwide to effectively help with rehabilitation of those involved with the justice system. The personal attention these courts foster is especially effective for persons with neurobehavioral issues like FASD and Autism.
- 4. Expansion of treatment programs statewide. I observed how hard it was for both adults and youth involved in the justice system to obtain needed and often mandated treatment in a timely manner. When a person is on felony probation or juvenile supervision, with a treatment order, and the person cannot obtain treatment for many months, the risk of recidivism is great. Treatment works and we need to make sure it's available in a timely manner to justice system-involved Alaskans.

It's unclear to me whether there's additional funding for public TV, but I would support that, too. In short, I encourage you to sufficiently fund all forms of public media in Alaska. As you're well aware, state funding of public media is especially important in Alaska for any number of reasons. I strongly support funding the Low Income residential Weatherization program. Numerous Alaska low-income residents remain in need of weatherization for their homes to reduce their utility burden, promote healthy indoor air quality and reduce future mold problems associated with poor ventilation. RurAL CAP seeks continued State of Alaska funding for the Weatherization Program.

DOE funding limits per home (approx. \$7.500.00-7,600.00), are not adequate to support the necessary infrastructure required to provide services in most rural locations without additional funding being added through the State of Alaska. In order to serve rural locations, DOE funding must consist of a blend of DOE and State funding to cover such additional costs as freight, storage and disposal of debris, along with other costs associated with construction in remote locations. Without State funding to blend with DOE, the DOE funding alone is not adequate to provide Weatherization, in rural locations.

The Weatherization Program has a proven payback record through energy usage reductions and improved health of occupants for all homes served by the program. Measures performed on any home must meet AKWARM program energy saving requirements approving the application of each measure applied to the home. Every home served with Weatherization must meet ASHRAE 62.2 indoor air quality standards also. Cold Climate Housing Research Corp. indicates that the overall average reduction in utilities usage in rural Alaska is 28%, which represents huge savings for any low-income family living in rural Alaska. Indoor air quality requirements add respiratory health benefits for Weatherization recipients also.

The housing crisis in Alaska is real and predominant in rural locations, with much of the housing stock already in poor condition. Rising water levels and melting permafrost are adding to the problems rural residents are facing with mold and overall house structure deterioration from rot associated with continuous moisture exposure. Weatherization improves the life expectancy of every home served. In rural Alaska, maintaining housing stock is a high priority with many residents realizing the existing failed and near failing homes all over the state. Rural residents have few if any options for renovation and updating of their home. Most are unable to upgrade their home for code compliance and overall health and safety.

Thank you for this opportunity to let you know about the importance of public radio to rural Alaska, including our listening area, which includes Ketchikan, Saxman, Metlakatla and much of Prince of Wales Island.

Thank you, also, for your past and continued support of state funding for public media. You understand that public radio is often the only source of local, state and national news for Alaska's isolated communities.

Now, especially, our listeners depend on us for up-to-the-minute reports about the pandemic, including government response. We have carried national, state and local briefings live numerous times in the last couple of weeks, and our one reporter is working more overtime than ever to keep the public informed about the local response.

Ketchikan had its first case of Covid 19 confirmed late yesterday. We had a news story online very quickly, and on the air just before and after the governor's live briefing last night. We have a continuously updated list of closures and cancellations on our website, which is a hub of information for our listeners on almost everything — not just pandemic news.

And during all this, I anticipate that, despite our constant efforts, our fundraising will plummet. The economic hit to our communities will mean less money for residents to donate to their public radio stations; and less money for businesses to underwrite. We are a critical state resource for disseminating information in all kinds of emergencies, and it is worthwhile for the state to provide funding for this service.
