In regards to the proposed legislation House Bill (HB) 300 and 306, it is important to recognize the impact to Alaskans. The two bills appear to be a reactionary effort that is the easiest route to solve the current issues without considering alternatives. A comprehensive approach to the current economic impacts facing the State of Alaska today is the best approach. Otherwise adopting either bill will have an inequitable impact to those in a lower socio-economic status. Instead a combination of oil tax, income tax, a 50/50 percentage split on the PFD, and at least a 10% cut in current spending in the next three to five years would create an equitable solution.

I'm Thomas Willard from Wasilla, Alaska. I saw where this Committee changed tomorrow's hearing on HB 300 to today. You need to give the public more time to adjust their schedules for public hearings not a 24-hour switch. After reviewing HB 300, I do NOT support HB 300 either.

First, the bill makes substantial changes to the current PFD statutory law & dedicates or designates a few broad categories for expenditures that also reduces the people's PFD to a 15% draw or split, contrary to the current 50/50 statutory model.

Second, the effect of this bill, if passed & signed into law, will be to further increase the size of government & our state budget. Haven't you legislators learned that you cannot spend more than you receive without endangering our remaining savings account – the CBR – and the people's PFDs? Apparently not.

Third, this bill authorizes more inflation-proofing. Didn't last year's bill to cap the PFD include enough inflation-proofing for the next 8 years?

Fourth, any changes to the PFD program should be brought to the voters for approval, if you want consent of the governed.

In conclusion, please quit stealing the people's PFD & let's have a statewide vote on any changes to the PFD program. Thank you for your time & consideration.
