To members of the House Finance Committee:

I am asking you to support Senate Bill 52which would revise Title 4 of the Alaska Statutes regulating alcohol beverages. This bill is the product of a seven-year process initiated by the Alcoholic Beverage Control (ABC) Board to engage a diverse group of more than 120 stakeholders across the state to determine how to improve the structure, organization, specific policies and associated implementation issues in Title 4, Alaska's statutes regarding regulation and control of alcoholic beverages in the state.

Title 4 is recognized to be in many ways outdated, confusing or otherwise ineffective in carrying out the intent of the statutes. Much of the chapter has not been updated since 1980. Over time, incremental updates and changing trends have reduced the effectiveness of Title 4. This systematic redraft of Title 4 will help the ABC Board carry out its mission and will benefit organizations and individuals whose work, community or business is affected by alcoholic beverage laws and regulations.

The proposed revisions in SB 52 are a comprehensive package of inter-related proposals to improve the overall system of alcohol regulation in Alaska. They will:

- Make Title 4 a clear and consistent framework used by licensees, the ABC Board and law enforcement
- Increase effectiveness of Title 4 enforcement by improving the swiftness, proportionality and consistency of penalties
- Increase licensee accountability before the ABC Board for Title 4 violations.

This package ensures that the Alcoholic Beverage Control Board fairly represents the interests of all Alaskans and will be a leader in alcohol education, policy and regulation. It will promote a fair business climate and protect public health and safety by:

- Creating a rational regulatory structure for Alaska's alcohol licensing system
- Limiting youth access to alcohol
- Promoting responsible alcohol use and reduce the harms of overconsumption.

I urge you to support the significant multi-year effort of this statewide stakeholder group by voting in support of SB 52 and improving Title 4.

The Alaska Mental Health Trust Authority supports CSSB52, representing revisions to Title 4 of the Alaska Statues regulating alcohol. SB52 is the product of a more than seven year effort to improve the structure, organization, and policies associated with Title 4.

The Trust has been an active partner during the multi-year Title 4 reform effort, along with a multitude of partners representing the alcohol industry, public health, and public safety. We are committed to this legislation as we see in it many public health benefits that directly impact the health and wellness of all Alaskans – and more specifically for beneficiaries of the Mental Health Trust. In addition to health-related impacts, alcohol abuse and over-consumption is costly to our state, the 2019 McDowell Report commissioned by the Trust clearly outlines those economic impacts- upwards of \$2.4 billion annually.

Title 4 is outdated as it currently stands, and does not create a clear and consistent framework for alcohol regulation. The Trust engaged in Title 4 reform early, recognizing that improving the statues will have a positive impact on public health. Limiting youth access to alcohol and controlling online alcohol sales are included in this bill and are examples of positive public health impacts. We also see value in better defining Alaska's alcohol laws, creating a clear framework that is easier to understand, comply with, and enforce.

SB52 creates a rational regulatory structure for our states licensing system and promotes responsible alcohol use – all while simultaneously supporting a fair business environment. SB52 represents the thoughtful, transparent, and stakeholder-driven process that contributed to the final recommendations included in this bill. SB52 has garnered unprecedented support of public health, public safety as well as the alcohol industry.

Dear Honorable Members of the House Finance Committee:

Senate Bill 52 (SB 52) is a product of over eight years of robust and earnest stakeholder engagement, that includes substantive improvements for all groups at the table – public health, public safety, state and municipal regulatory bodies, and all three tiers of the industry.

Following the 2019 legislative session, the Alaska Cabaret, Hotel, Restaurant, and Retailers Association (Alaska CHARR) – who represents over 750 members statewide – and the Brewers Guild of Alaska (BGA) made a mutual decision to pursue a compromise between retailers and manufacturers in the interest of finding a path forward and to obtain united support for SB 52.

Alaska CHARR and the BGA spent the 2019 summer and fall meeting to discuss the sections in previous iterations of the Title 04 update that included the most contentious issues between our organizations' members. In January, the boards of directors for both Alaska CHARR and the BGA unanimously voted to approve the challenging, yet thoughtful compromise between industry tiers regarding provisions around manufacturing retail licenses. These disagreements had hindered passage of previous iterations of the Title 04 rewrite.

The impacts of COVID-19 have reverberated throughout the state, with few industries being hit harder than tourism and hospitality. Alaskan businesses – particularly smaller ones – have already felt the impacts. These are the places you celebrate your birthdays, sports victories, marriages, anniversaries, and even just the places you go to get away from the stresses of life. They are the heart of every community across our great state and right now, many are struggling to survive.

This will inevitably be one the worst Alaska tourism seasons in decades, which will be detrimental to our state, as only oil brings more dollars into Alaska each year. I expect that some Alaskan businesses will not recover from this, yet we are fighting tirelessly to ensure that as many as possible will remain operating for years to come.

As you know, the House Finance Committee is the final stop for SB 52.

SB 52 is a piece of legislation that is both pro-business and pro-public health. I implore you to support the Alaska hospitality industry when it needs you the most by moving this legislation expeditiously, so we might collectively turn out attention to surviving this crisis – both in health and in business.

CSSB 52(FIN) AM also reduces business for local providers (we use locally grown hops, honey, birch syrup and fruit, all produced locally, as well as natural gas, and other commodities), slows new construction and restricts local job development. Alaska now more than ever before needs to promote local businesses for a desperately needed beneficial outcome.
