Re: Support for SB52 Alcoholic Beverage Control; Alcohol Regulation

Dear Representative Foster, Representative Johnston and Members of the House Finance Committee:

Southcentral Foundation would like to express its support of HB 268, which would revise Title 4 of the Alaska Statutes regulating alcohol beverages.

Southcentral Foundation (SCF) is the Alaska Native tribal health organization designated by Cook Inlet Region, Inc. and eleven Federally-Recognized Tribes – the Aleut Community of St. Paul Island, Igiugig, Iliamna, Kokhanok, McGrath, Newhalen, Nikolai, Nondalton, Pedro Bay, Telida, and Takotna – to provide healthcare services to beneficiaries of the Indian Health Service pursuant to a compact with the United States government under the authority of P.L. 93-638, as amended, the Indian Self Determination and Education Assistance Act.

SCF provides services to more than 65,000 Alaska Native and American Indian people living in the Municipality of Anchorage, the Matanuska-Susitna Borough and 55 rural Alaskan villages. Services provided by SCF include outpatient medical care, home health care, dentistry, optometry, psychiatry, mental health counseling, substance abuse treatment, residential treatment facilities for adolescents and for women, suicide prevention and domestic violence prevention. We employ numerous staff, all of whom work in harmony to treat patients for the best access to quality care.

Senate Bill 52 is the product of a seven-year process initiated by the Alcoholic Beverage Control (ABC) Board to engage a diverse group of more than 120 stakeholders across the state to determine how to improve the structure, organization, specific policies and associated

implementation issues in Title 4, Alaska's statutes regarding regulation and control of alcoholic beverages in the state. I have tracked this process with great interest, both from a healthcare perspective and because I am also the chair of the steering committee of Recover Alaska.

Title 4 is recognized to be in many ways outdated, confusing or otherwise ineffective in carrying out the intent of the statutes. Much of the chapter has not been updated since 1980. Over time, incremental updates and changing trends have reduced the effectiveness of Title 4. This systematic redraft of Title 4 will help the ABC Board carry out its mission and will benefit organizations and individuals whose work, community, or business is affected by alcoholic beverage laws and regulations.

The proposed revisions in SB 52 are a comprehensive package of inter-related proposals to improve the overall system of alcohol regulation in Alaska. They will:

- Make Title 4 a clear and consistent framework to be used by licensees, the ABC Board, and law enforcement;
- Increase the effectiveness of Title 4 enforcement by improving the swiftness, proportionality, and consistency of penalties; and
- Increase licensee accountability before the ABC Board for Title 4 violations.

This package ensures that the Alcoholic Beverage Control Board fairly represents the interests of all Alaskans and will be a leader in alcohol education, policy and regulation. It will promote a fair business climate and protect public health and safety by creating a rational regulatory structure for Alaska's alcohol licensing system, limiting youth access to alcohol, and promoting responsible alcohol use and reduce the harms of overconsumption.

I urge you to vote in support of SB 52 and improving Title 4. Thank you for your consideration of our comments and recommendations.

We started the title 4 rewrite several years ago due to the age of this statute which had grown out of date with todays market place and changes in the our current business trends that seem to need additional support and direction from our legislators. Truly thousands of hours by many industry owners and operators, along with Health & social services, law enforcement, as well as stakeholders have found this current rewrite satisficing on many fronts that entice our industry and regulators. I began working on the stakeholder effort to reform Title 4 in 2012 when I was the Anchorage Municipal Prosecutor. My participation in that role tells you how far-reaching the bill is- the Chief of Police of the Anchorage Police Department urged me to join because Title 4 was impeding improvement of the downtown district in many ways. Clarifying the rules set forth in Title 4 will help downtown businesses come into compliance and understand sure and certain penalties for violations.

While at the ABC, I was active in the stakeholders group and updated the Board on the progress of the effort. By 2016 we had invested multiple thousands of hours of work on the language and concepts in this bill. I cannot even imagine how many hours are invested now. To say that everyone has worked very hard on a compromise is an understatement.

Here are things for you to realize about the bill in its current form:

- SB 52 is the product of over eight years of stakeholder engagement, compromise, and consensus between all parties, including public health, public safety, state and local governments, and all three tiers of the industry.



On behalf of the Mat-Su Health Foundation and its Board of Directors, I am writing to express support for SB 52: Alcoholic Beverage Control. The Mat-Su Health Foundation (MSHF) shares ownership in Mat-Su Regional Medical Center and invests its profits from that partnership back into the community in order to improve the health and wellness of Alaskans living in the Mat-Su.

MSHF and our community partners conduct a Community Health Needs Assessment every three years. In our 2013 assessment, alcohol and substance abuse were ranked as the number one health issue in Mat-Su. In follow up research, we asked our local police captains, what is the number one substance use problem? Their response was "alcohol, alcohol, alcohol," Unfortunately, not much has changed since then. The number one reason Mat-Su residents visit our local hospital's emergency department for behavioral health needs is alcohol-related disorders. Alcohol is a major factor in many crimes committed in Alaska, including domestic violence and child maltreatment.

Revisions to Alaska's alcohol laws can help correct some of these problems. Current Title 4 statute is recognized in many ways to be outdated, confusing or otherwise ineffective in carrying out the intent of the law. Much of the chapter has not been updated since 1980. Over time, incremental updates and changing trends have reduced the effectiveness of Title 4. This systematic redraft of Title 4 will help the ABC Board carry out its mission, and it will benefit organizations and individuals whose work, community or business is affected by alcoholic beverage laws and regulations. The Mat-Su Health Foundation is particularly interested in the public health aspects of SB 52:

- SB 52 helps prevent underage drinking. The bill requires keg registration, and it gives the state additional tools for controlling online alcohol sales. Alaska is one of the only states with no regulation of Internet sales of alcohol.
- SB 52 supports better enforcement of alcohol laws, as well as more education to businesses and communities about following the laws and operating responsibly.

It's remarkable that so many stakeholders have been able to come together and reach the compromises reflected in SB 52. This is a bill that is good for all Alaskans; it limits youth access to alcohol, promotes responsible alcohol use by adults, and will result in reduced harm. We respectfully ask you to support its passage in this legislative session.
