**Re: SUPPORT for H.B. 198, Testimony from the Human Rights Campaign in support of the bill to expand hate crime protections to include LGBTQ people**

Dear Chairperson Kreiss-Tomkins and Members of the Committee:

The Human Rights Campaign (HRC), on behalf of its more than three million members and supporters, including more than 12,000 members and supporters in Alaska, thanks you for the opportunity to submit testimony on H.B. 198, a vital measure that would protect the lesbian, gay, bisexual, transgender, and queer community from bias-motivated crimes. We urge you to swiftly pass this important legislation.

HRC is America's largest civil rights organization working to achieve lesbian, gay, bisexual, transgender, and queer (LGBTQ) equality. By inspiring and engaging all Americans, HRC strives to end discrimination against LGBTQ people and realize a world that achieves fundamental fairness and equality for all. As an advocate for LGBTQ individuals, HRC is a strong proponent of laws and policies that seek to safeguard LGBTQ people and other marginalized communities from the rising scourge of hate crimes.

Every year, thousands of violent hate crimes occur, affecting not only the victims and their families, but also the entire communities they target. Sadly, LGBTQ people are disproportionately the target of these crimes. The latest 2018 Federal Bureau of Investigation (FBI) hate crimes report revealed that although the overall number of reported hate crimes decreased slightly since 2017, incidents based on the victim's sexual orientation or gender identity increased from nearly 18% of all reported incidents in the previous year to nearly 19% in 2018.<sup>1</sup> This report revealed that an alarming 1,634 victims were targeted based on their sexual

orientation or gender identity in 2018, 136 more than in 2017.<sup>2</sup> Importantly, because reporting hate crimes to the FBI is purely voluntary under federal law, the actual number of hate crimes across the country is drastically larger than the FBI's latest report indicates. Additionally, according to a recent U.S. Department of Justice report, about 54% of hate crime victimizations between 2004 and 2015 were not even reported to local police.<sup>3</sup>

This unfortunate reality demands bold action. H.B. 198 would begin the process Alaska must undertake to protect all of its citizens from the threat of hate-motivated crimes by expanding the state's current bias-motivated crimes law to expressly include sexual orientation and gender identity. This bill would also send a strong message that hatred and prejudice are not Alaska values, that everyone is welcome in Alaska and should be able to live their lives free from the threat of hate-motivated crimes.

Thank you for the opportunity to submit testimony in favor of this critical bill to protect the safety of LGBTQ Alaskans.
