Committee Co-chairs:

Anchorage Independent Longshore Union, Local 1 (AILU) represents over 300 workers for the Port of Alaska which needs funding for refurbishment and modernization. Since before AILU's inception in 1974, Anchorage longshoremen have handled the cargo brought to Alaska through the Port, and plan to continue doing so far into the future. Funding is a crucial necessity for the Port to continue operations at its current levels of approximately 1,000 containers per day.

The Port is the linchpin for Alaska providing supplies to the road system. Food, pipeline material and other goods off-loaded by AILU members are then brought to the interior and Kenai Peninsula and are the lifeline for Alaska's development and food security. AILU works a 24/7 schedule to ensure that goods are offloaded when the cargo ships come in, and the distribution of goods timely gets out for delivery.

With more federal dollars being made available, it is crucial that Alaska be competitive in applying for these grants to secure money over larger ports across the country. AILU fully supports the \$200 Million appropriated for the Port of Alaska modernization with the purpose of matching each dollar received in federal funds in the House Finance committee substitute version G working draft. This funding will allow for better competition for the Port of Alaska to obtain grants and more federal funds.
