



COVID-19 Impact to DPS Budget

- Life safety inspections are down by 83% and at least \$263.0.
- Plan review office has seen a reduction in the amount of \$254.0.
- Receipts for background checks were down 17% (\$293.0) for the first two quarters of FY 2021 compared with the first two quarters of FY 2020.



COVID-19 Impact to DPS Budget

- DPS was granted \$3,600.0 from the Coronavirus Emergency Supplemental Funds (CESF) from the US Department of Justice
 - \$902.0 out of the \$1,000.0 has been granted out to local public safety agencies.
 - \$1,000.0 provided to other state public safety agencies.
- DPS Aircraft Section has seen an increase of 75% in maintenance costs and 74% in Jet-A fuel costs.
 - 1498.4 flight hours in 2020 as compared to 861.0 for 2019.
