Dear Co-Chairs Stedman and Bishop,

Thank you for inviting the Office of Management and Budget to present on the Governor's fiscal year 2021 deferred maintenance capital budget to the Senate Finance Committee on Tuesday, February 23rd. Responses to questions and requests for follow-up information from the committee hearing are included below:

Senator Wilson asked about the budget shortfalls that would be created if the reverse sweep is not enacted.

Impacts will be mitigated by enacting section 28(a) of the Governor's proposed FY22 operating budget.

Senator von Imhof asked as the department is reviewing properties, has any space been added to potential disposal list due to reduced space needs because of COVID19 telework practices? The property disposal consolidated report was completed prior to the Pandemic. There would need to be an extensive review internally from an HR and administrative programmatic perspective before the space evaluation can occur.

Senator Stedman requested an updated 2021 list of State Facility Council Property Disposal Report. Provided as Attachment 1.

Senator Wielechowski asked when the project index methodology adopted by the state and whether it is standard in other states/industries. The project index methodology was adopted by the state in the Spring of 2020. Other states and industries use similar methods to prioritize their projects, however, each entity incorporates their own unique and specific criteria.

Senator Stedman asked for the current status of deferred maintenance needs of the Governor's mansion and the Wickersham House in Juneau.

The radiators are the only official item on the Deferred Maintenance (DM) list however DNR staff are in the process of updating the DM list. Items that may be added are noted below. For each item, costs have not been gathered. Once the project is confirmed and the estimated costs are known, they will be added to the DM list.

- 1) Front door concrete step replacement The old steep concrete steps/stoop has separated from the foundation and is settling/leaning. This must be replaced. At a minimum, the stairs will be matched and replaced however we will also look into replacing with an ADA ramp and stair system.
- 2) The back sunporch appears to be settling or had settled and was in need of leveling/repair We will need to wait for the snow to melt and weather to improve to verify.
- 3) There is also an old shed that needs to be rebuilt/repaired or eliminated it is not an historic structure, just a large "garden/lawn" shed. If replaced, it should be relocated and built to match the historic appearance of the house and time period.

Senator von Imhof asked for the year of disposal for list on Slide 27 of the presentation. Are any buildings currently for sale? If so, how long have the properties been on the market?
