Dear Chair Wilson, Vice-Chair Hughes, and Members of the Senate Health & Social Services Committee:

The ACLU of Alaska opposes Senate Joint Resolution (SJR) 4. This resolution's goal is to erode the Alaska Constitution's privacy protections and equal protection guarantees, and to chip away at a woman's right to control her body.

Living a safe and healthy life is a basic right, as is the freedom to define our own path. We aren't truly free if we can't make our own decisions about our bodies, our lives, and our futures—whether that is saying no to unwanted sexual advances, no to an unintended pregnancy, or yes to becoming a parent. When someone decides to have an abortion, it should be safe, affordable, and free from punishment or judgment.

The decision about whether and when to become a parent is one of the most important life decisions we make. When people can make decisions that are best for their lives, families thrive and we build communities where each of us can participate with dignity and equality. When the state denies that ability through restrictions on abortion, however, the harm falls hardest on those struggling financially or those who already face significant barriers to health care, such as high transportation costs and long travel time associated with accessing care for people living in rural Alaska. People who are denied abortion care are more likely to experience poor health outcomes, fall into or remain in poverty, and be unemployed than those who obtain care. SJR 4 would open the door to restrictions that make these outcomes more likely and push safe abortion care further out of reach.

Alaskans are rightly proud of our constitution, which contains robust privacy protections and guarantees of equal protection. These protections include safeguarding a woman's right to decide whether and when to become a mother. The ACLU of Alaska is proud of our decades-long track record successfully litigating unconstitutional laws targeting women's

reproductive rights. Through these and other cases, the Alaska Supreme Court has made clear that reproductive rights, including the right to abortion, are fundamental rights. The State may not infringe on the fundamental privacy right to make reproductive decisions except "when necessary to further a compelling state interest and only if no less restrictive means exist to advance the interest."

We appreciate the opportunity to share our concerns about SJR 4 with the Senate Health and Social Services Committee. We recognize this resolution as an attempt to lower the constitutional guardrails that protect Alaskans' fundamental right to make reproductive decisions, and to dismantle people's ability to get safe, legal abortion care. For these reasons, we oppose this resolution and urge the Committee to reject it.

I am a law student and former abortion clinic manager currently living in Anchorage. I had prepared remarks before this hearing, which I feel compelled to stray from in order to address several misstatements of fact and law made by Senator Hughes.

Roe v. Wade recognizes a substantive right to privacy between a patient and her doctor, not specifically to abortion. The Alaska founders enshrined in the Alaska State Constitution that the people's right to privacy is recognized and shall not be infringed. On its face, Senate Joint Resolution 4 would cause undue confusion because it conflicts directly with other provisions in the Alaska State Constitution, specifically women's equal rights under the law and our right to privacy.

In pertinent part, this Resolution states, "[t]o protect human life, nothing in this constitution may be construed to secure or protect a right to an abortion or require the State to fund an abortion." When I managed an abortion clinic in North Carolina, I encountered patients whose lives depended on their access to safe and affordable healthcare, including therapeutic abortion. A woman's age and myriad medical conditions may make carrying a pregnancy to term a life-threatening physical impossibility. For this reason alone, the Resolution's stated purpose to protect human life is patently incorrect.

Therapeutic abortion ensures that women are able to safely carry a pregnancy to term when they have the medical, financial, and emotional support necessary to do so.

I managed a clinic in North Carolina, where there are parental consent laws as well as a 72 hour waiting period between nurse counseling and a procedure. On a weekly basis, we had to turn patients away who came in with their parents because they did not have the requisite documentation. This sometimes postponed the procedure to the point that a prohibitively expensive procedure was necessary. The policies the sponsors of this resolution wish to create a path for are just an unnecessary hurdle for young women in a difficult and sensitive situation.

The sponsors of the Resolution claim that it will allow voters and legislators to set policy in regards to abortion. Unfortunately, most voters and legislators are not qualified to set healthcare policy that best serves women and children. The "common sense" abortion policy advanced by Senator Hughes does not comport with the medical science.

I sincerely appreciate your time, and hope that you oppose Senate Joint Resolution 4.

Individual beliefs on when an abortion is morally acceptable vary dramatically from person to person. I personally do not believe that abortion is murder and would get one were I to become pregnant. Thank you for the time to testify today in opposition to Senate Joint Resolution (SJR) 4. A typed copy of my oral testimony follows.

Thank you, Mr. Chair and members of the Senate Health and Social Services Committee for the opportunity to testify today. For the record, my name is Mary Elizabeth Kehrhahn-Stark. I live in Senate District B and I am representing myself. I oppose SJR 4, a proposed constitutional amendment that would erode the Alaska's Constitution privacy protection.

In my opinion, SJR 4 is an example of what right to life supporters in our legislative body want so badly to accomplish, that is to abolish a woman's right to privacy in her thoughts and actions. By permanently changing our Constitution, our legislature would be able to decide a citizen's right, opportunity, and protection under the law.

The reality is that ultimately, the most affected by this proposed amendment are the most vulnerable members of our communities, since the typical abortion patient is disproportionately single, very poor-living at 100-199% of the federal poverty level, and low income-living at less than the federal poverty level. The current poverty level for an Alaskan household of 1 is \$15,950. The result of an unwanted birth to this single female Alaskan assigns her as a head of her household with children, making her a member of the largest population group living in poverty in the United States.

On a more personal note, I am 64 years old now, but during another time in my life, I was young, and barely supporting myself. I was going to school to hopefully secure a better life for myself and for my community. I had to make this decision to continue, but I knew then, as I know now, it was the best decision of my life. I thank God that abortion was a safe, legal option because at the time, I knew I was not ready emotionally and financially to be a mother of a child.

I plead that you reject SJR 4, because each Alaskan, regardless of financial status, deserves the opportunity to control their own life at the most basic level, that is control of their own bodies, their own family, and their own life choices.

I am appalled that once again, your valuable time is being taken up by a completely unnecessary, illogical, illegal, and harmful proposed piece of legislation: SJR 4. Contrary to the many decades upheld Supreme Court decision of Roe v. Wade and the Alaska Constitution's privacy clause, some are trying to again worm their way into a woman's body and her most personal choices.

This proposed amendment would set the stage to ban abortions in Alaska. If an Alaskan personally opposes an abortion, fine, that is their choice and their body. But others, particularly men, have no right to impose that very personal choice on the very personal choice of what another may find at some time a necessary choice for them.

And then, are there people jumping up to care for the future life they may doom some woman to carry? If that fetus was created while someone was addicted to drugs or alcohol, does the state have resources ready to pay for the medical, emotional, and other tremendous social service costs that may result from a person being forced to carry a fetus to term that may be born in a condition requiring extensive medical or psychological or other interventions in order to thrive. If someone does not want to be pregnant, will they eat healthy, not smoke or drink, or do they even have access to healthy food and knowledge on how to produce a healthy baby?

Are those working so vehemently to prevent abortions also so enthusiastically speaking up to adopt the babies who would instead need to be adopted? Too many of these babies would each likely need hundreds of thousands of dollars in medical and social services care throughout their lives. That will be the expected fate of fetuses born addicted to drugs through a drug addicted mother, born with Fetal Alcohol Syndrome and subsequent learning, social, and emotional challenges, or those which may be brought up in an abusive, violent, or unloving atmosphere. Our Governor and Legislature have already significantly cut funding for health and social services — raising this amendment and its potential passage would result in a huge unfunded mandate.

Nor does there seem to be any concern for the poor woman who would be forced to go through this trauma, after making a tremendously difficult decision to pursue an abortion she cannot safely have. Why is the Legislature considering a bill that will push the government into a woman's body and her most personal decision? Our State Constitution has, from its inception, protected an individual's right to privacy, a right of which all Alaskans have been proud and protective since statehood. Thus, the Legislature has no business raising an amendment that would interfere with a woman's decision that has resulted from an accident, a mistake, or is the result of an act of violence or other abuse.

Your Committee time, and the time of the Legislature as a whole would be much better spent balancing our State budget, fully funding education for all our children, and addressing overall public safety, rather than on the personal issues of a few women. Shame on you if you vote to approve this bill. Please vote **no** on SJR 4 now, and do not consider raising or passing anything similar!

To the members of the Health and Social Services Committee,

I was unable to attend today's hearing to provide testimony in opposition to eliminating my constitutional right to abortion. I am typing this out after work, before I provide care for my eleven-year-old child with disabilities as a single parent, meet with the board president of the organization I volunteer with, and try to squeeze in some self-care in the middle of a global pandemic.

When I was twenty, I had an abortion. While it was one of the most difficult choices I've made in this life, it's also one that I am always grateful to have been able to make. I was too young and not ready to raise a child. I am also an adopted person and intimately understand the trauma that comes with parental separation at birth via adoption. It was not a choice I was willing to make for what would have been my child, had I carried that pregnancy to term.

Despite my personal experience, access to abortion is a human right and at times a medical necessity. Not all women can safely carry to term. Not all want to. There is no religious argument to be made, because of the separation of church and state. But if I were to appeal to your morality, it would ask- what is the value of merely giving birth to a child but not giving a life to one? Without health care (Alaska Legislature continually attempts to and cuts back Medicaid), without education (Alaska Legislature has not raised the student base allocation in years and cut UA's budget by millions), without housing, what life are we offering to children we would force to be born without the basic supports needed to survive, not to mention thrive?

If this resolution isn't eliminating the right to abortion, just the funding mechanisms that make it accessible to women on limited incomes, I would argue that eliminating state-sponsored healthcare funding for abortion effectively eliminates access to abortion for low-income or no-income women. I haven't reviewed the Kids Count data recently, but I would estimate around 25% of households in Alaska are single female parent households. The responsibility of parenting falls on women socially and economically. Putting the burden of funding the choice to family plan on women is patriarchal and gross.

It appalls me that this resolution is being entertained. I can only hope it is politicking to garner favor in the eyes of constituents and that no one actually hopes that we can move forward with eliminating my legal right to access abortion in Alaska. I stand with every person in our state who has had an abortion, will need to have one or wants to have one.

I ask that you do what's in the best interest of women across Alaska and not move this resolution forward past committee.



My name is Zoe Cramer, and I am a voter who lives in Homer, Alaska.

I appreciate you taking the time to read my testimony with an open mind and heart.

I was born in Homer, Alaska, to a mother and father that had met a month before my conception. At the time, they were living in a tent on the Kenai River, and both were working as seasonal employees at a bait shop. When my mom realized she was pregnant, even though she had no steady income, house, and had just moved to the state, she decided to have a baby. Well, my mom and dad weren't in love, and a child, as some of you might know, doesn't always make a relationship stronger. So I've grown up with mixed families: stepparents, step-siblings, half-siblings. And I've also grown up in poverty. The government paid for my school lunches, clothes, school supplies, field trips, health insurance, and everything in between. I have leaned on government support since the moment I was born, through my physical conditions as a child and through my mental conditions as a teenager and young adult, of which I am very fortunate for those government programs. I am also very fortunate to have family, although not cohesive and not always financially stable, a family that wants me in their lives and chooses to support me.

And I am not here today to argue my moral or religious opinions on abortion. Everyone has most likely come to their own conclusions, and so I'm not going to change your mind on that. Instead, I would like you all to think about the financial implications of bill SJR 4.

#### The bill states.

"To protect human life, nothing in this constitution may be construed to secure or protect a right to an abortion or require the State to fund an abortion."

So I'd love to quickly share some statistics of who's receiving abortions, who is paying for them, and what happens after a child who is not wanted by their family is born.

So let's go into what statistical group of Alaskans are receiving abortions.

The majority, 60%, of people receiving abortions are in their 20s. I think we all understand why someone in their 20s might not want children—college, career, travel, not being financially stable. In fact, 75% of patients receiving an abortion were low income. 49% living under the poverty line, 26% living with half or 1/4th of the budget of someone living on the poverty line. So ½ people receiving abortions are not financially stable enough to take care of a child. Which, in the first year, averages \$13,000. The poverty line in a two-person household is \$21,770. The poverty line of a one-person household is 16,090. I trust you all can understand why that might be a problem.

Because of these numbers, one might assume that then most abortions are paid for by Medicaid, a government health insurance funded by both the federal and state government. However, most patients, 53% pay out-of-pocket, while only 24% were paid for by Medicaid.

So let's picture a world where abortion is unavailable for these low-income, young adults. They could find a family to adopt their baby or have the baby go to a foster care family. And this is really what I am concerned about for those who want to keep government spending at a minimum. Every year there are about 1500 abortions in Alaska. An abortion can cost anywhere from 75 dollars to a thousand, depending on many factors.

While every month, there are around 3,000 children in the Alaskan foster care system. Foster care families receive about \$90 a day per child and about 1500 dollars for completing the training and receiving the certificates that the state requires. Just some quick math, 3,000 times 90 times 365 days a year \$98,550,000. And that's not counting extra funding provided for their school, health care, and so forth.

Now I'm not in favor of reducing people down to numbers, and I personally have benefited greatly from government programs. However, I know many people in our state genuinely care about being fiscally conservative and saving our government funding for things like roads, public services like local government, police, firefighters, and so on.

These kids that grow up in the foster care system go through a lot of trauma. They likely have lived with multiple families, moving around a lot, and not ever truly knowing who will take care of them. Except, one thing that is consistent in their lives is government funding. These children, who turn into adults in our society, are majorly disadvantaged and are more prone to unemployment, homelessness, drug use, chronic illness, and illegal activity that often leads to jail or prison. Although I'm sure people here know of children who got lucky and found a family that accepted them and will love and cherish them well after they turn 18. There are many more who are not as lucky.

It's sad to face the reality, of unwanted children, without families to lean on in times of crisis. It's very heartbreaking to see that their central support system becomes our federal and state government programs. And I know it's not pleasant to think about, but the numbers tell us that these children, then teenagers, then adults, then seniors will end up costing our state government millions of dollars a year. In comparison, abortions end up costing a couple thousand, not even coming close to a million. And I apologize if I come off as lacking humanity, I do genuinely empathize with those who were not as lucky as me to have parents who, despite their young age, financial situation, and health, chose to raise me.

But returning to the bill language itself, "to protect human life." I'd like us all to contemplate what this truly means. Because although I do believe that I and everyone here has a right to live. I believe living, being alive, is not enough. People need shelter, support systems, food, clean water, hobbies, an education. And if you are willing to amend our state constitution, ensuring that the law does not "secure or protect the right to abortion," then you inherently must be willing to fund the care and protection of those thousands of children. You must be willing to pay for their basic human needs so that they too can become productive, contributing citizens of our beautiful state.

I was just checking my email and I saw something about SJR 4 today. As you might remember, I am a libertarian\* who ran as an independent for Senate this year. I want to register as opposed to SJR 4.

Alaska was one of the first states to allow legal abortion, a few years before the famous Roe v. Wade. Alaskans, and especially Alaskan women, value their independence and their ability to support themselves and their families, WITHOUT INTERFERENCE OR MONEY FROM THE STATE. They value their privacy. What you are planning is to force women to be subservient to the state and have no choice in their lives or careers.

Not only that, in a party that claims to want to cut the spending of the Department of Health and Social Services, you are obligating the state to finance the birth and support of over a thousand new children every year. Just one birth costs a minimum of \$10,000-15,000, so we are talking millions of dollars for the births alone, and much more to pay for the prematernal care and support of mother and child.

My personal belief is that I could never choose an abortion, and I never did. 95% of all mothers feel the same way as I do. I ask you to consider that 5% of women who are desperately conflicted about how they will support themselves and a child, how they are considering their jobs or careers, and how it is possible that they have no desire to have a continuing relationnship with the fathers of the offspring. We already have an overburdened Office of Children's Services and foster care system, too.
