Information on cost per student

Since state funds are driven by student enrollment during the budget year, it is most accurate to look at past years for a true picture of a per student cost. FY 20 is used as a pre-covid consideration. FY 22 is expected to be similar for formula funds.

Per Student Cost

To provide a consistent comparison of state dollars, the published "State Aid to Each District" found on the State website at <u>https://education.alaska.gov/schoolfinance/foundationfunding</u> was used for state funds amounts. Student enrollment numbers from the State web page, Department of Education and Early Development data center <u>https://education.alaska.gov/schoolfinance/foundationfunding</u> was used to provide enrollment for a per student calculation.

MEHS cost per student including residential state dollars would rank at 19 out of 54

other districts receive state residential funds through a separate formula, not included

Impact Aid off-set state contribution to formula

Impact aid are federal funds provided to schools for students who live on non-taxable land such as federal land, military bases, and Native land. Many of the MEHS students who come from small remote places generate federal impact aid by living on Native land. These federal dollars off-set the state required contribution. Since Sitka has a much lower cost differential than many of the rural communities, the federal funds off set a larger portion of the formula.
