EXPLANATION: A fund source change to utilize Federal Transit Authority money to replace Marine Highway System fund. Appropriations from the AMHS Fund are receipt authority to use the revenue generated by the Marine Highway System. Replacing this fund source in Marine Highway System appropriation and removing it from other non-AMHS appropriations in the DOT&PF budget for a fiscal year allows for the unspent revenue generated by the AMHS to capitalize the AMHS Fund and help it to become a more stable fund source for future years.
