FISCAL NOTE ANALYSIS

BILL NO. HB 111

Analysis

HB 111 creates a new advanced practice permit for dental hygienists. Currently, a dental hygienist may seek to perform certain dental hygiene procedures outside of a dental office under a board-approved collaborative agreement with a currently licensed dentist who has a dental practice in the state. HB 111 allows the dental hygienist more autonomy to be an independent contractor and increases the hygienist's scope of practice.

This bill will allow dental hygiene preventive services to be performed outside of a dental office in facilities where patients may be unable to travel to a dental office due to age, infirmity, or disability. This would allow dental hygienists greater opportunity to perform hygiene preventive procedures for underserved or indigent populations.

Services:

\$1.7 for legal costs to amend regulations, printing, and postage in the first year

Professional licensing programs within the Division of Corporations, Business and Professional Licensing are funded by receipt supported services, fund source 1156 Rcpt Svcs (DGF). Licensing fees for each program are set per AS 08.01.065 so the revenue collected approximately equals the occupation's actual regulatory costs.
