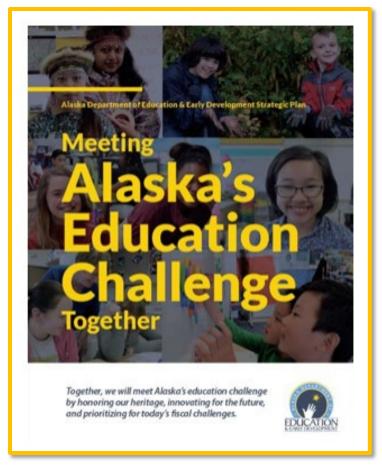

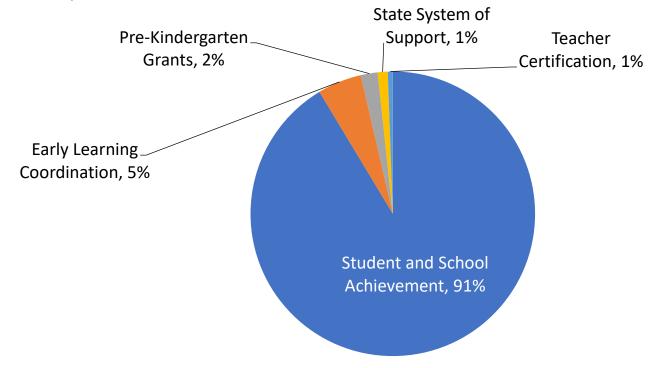






FY2022 Governor's Budget – Division Program Funding

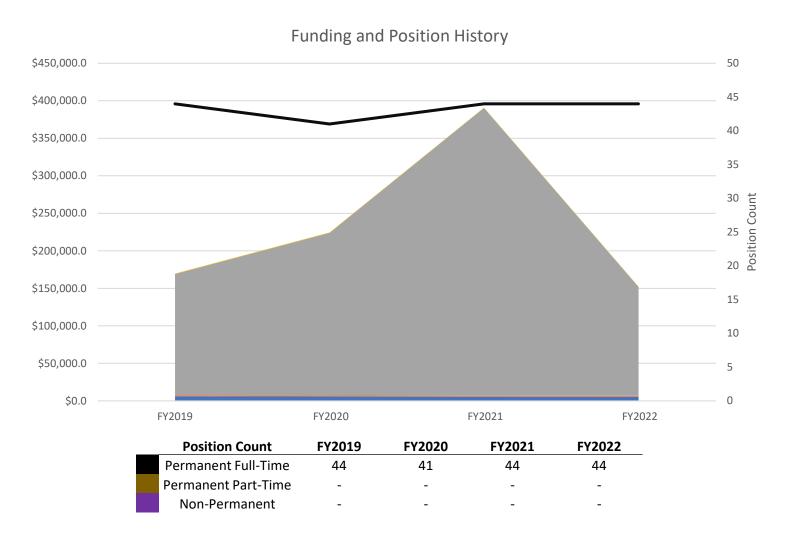

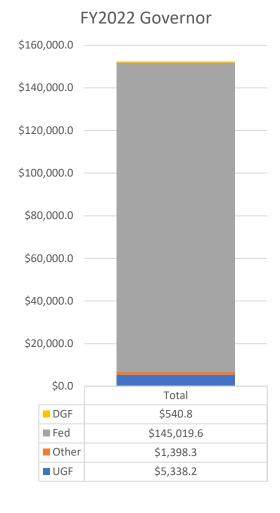

> Provide resources to school districts to ensure that special populations of students meet the state's high academic standards; to improve performance through professional development, school accountability, standards and assessments; improved health, safety, and alternative education opportunities; increase engagement with career and technical education; and, to provide school districts and stakeholders with high quality information to aid in data driven decision-making processes and reporting.

> FY2022 Governor's Budget Changes from FY2021

- \$33.6 (\$7.7 UGF, \$0.8 Other, \$25.1 Fed) Contractual Salary Adjustments
- (\$10.0) UGF travel reduction due to the increased availability of virtual meetings and conferences
- (\$230.0) UGF contractual services reduction to eliminate duplication of data analysis by the department
- (\$62.6) DGF reduction to the Technical Vocational Education Program (TVEP) distribution based on the Department of Labor and Workforce Development's projected distribution
- AMENDMENT (\$3.4) UGF reduction for the Career Technical Education (CTE) federal match requirement
- SUPPLEMENTAL (\$41.5) DGF reduction to the TVEP distribution based on the Department of Labor and Workforce Development's projected distribution for FY2021

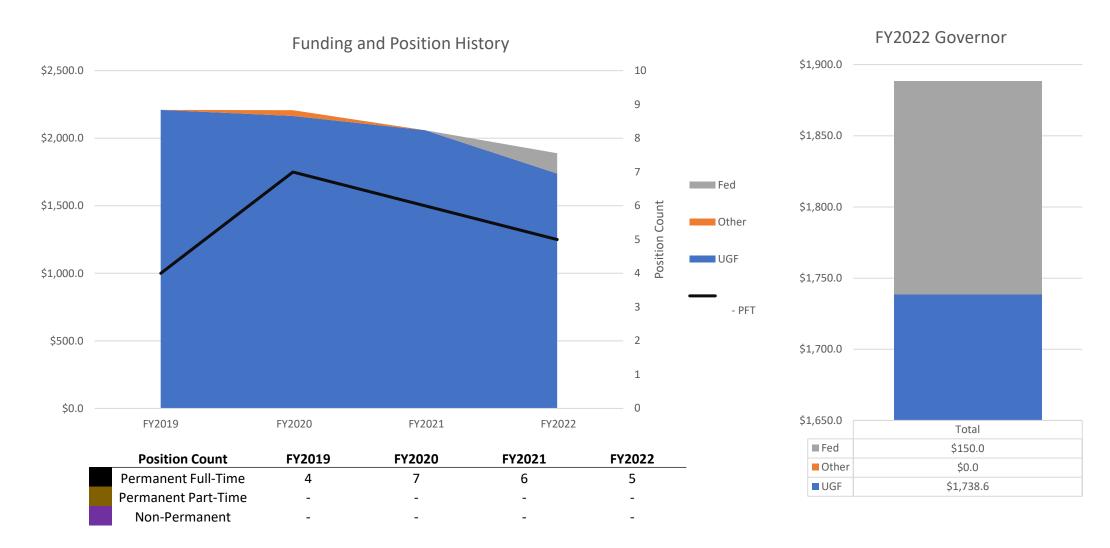

 - \$3.5 UGF Contractual Salary Adjustments
 - (\$15.0) UGF travel reduction due to the increased availability of virtual meetings and conferences
 - (\$50.0) UGF contractual services reduction due to modification of Coaches contracts moving to virtual meetings
 - (\$109.2) UGF and delete 1 PFT vacant Education Associate II position
 - Net \$0.0 change (\$150.0 Fed, (\$150.0) UGF) adjust funding source for an Education Specialist II position

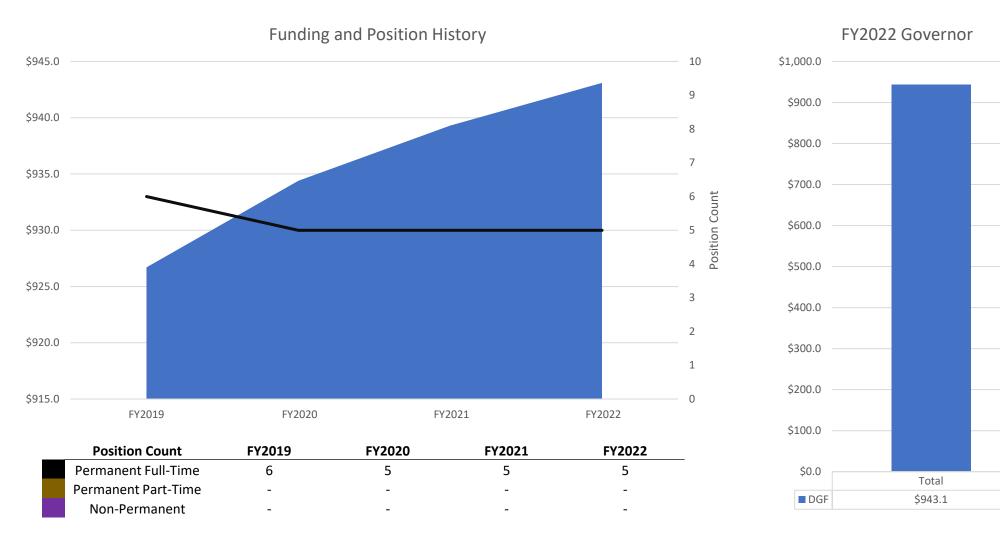

Budget Component: Teacher Certification

> Per Alaska Statute and regulation, ensure that only qualified applicants are certified to teach in Alaska and that teacher education programs in Alaska conform to nationally recognized standards

- > FY2022 Governor's Budget Changes from FY2021
 - \$3.8 DGF Contractual Salary Adjustments



Budget Component: Teacher Certification Receipt Funding

- > Per AS 14.20.020, certification fees are collected from applicants to pay for the cost of certifying and disciplining Alaska educators
 - Certification fee is currently \$200 per certificate
 - Revenue collected support the annual budgets for Teacher Certification and the Professional Teaching Practices Commission (PTPC)
 - Teacher Certification's budget includes carryforward language allowing unspent receipts to be carried forward into the next fiscal year

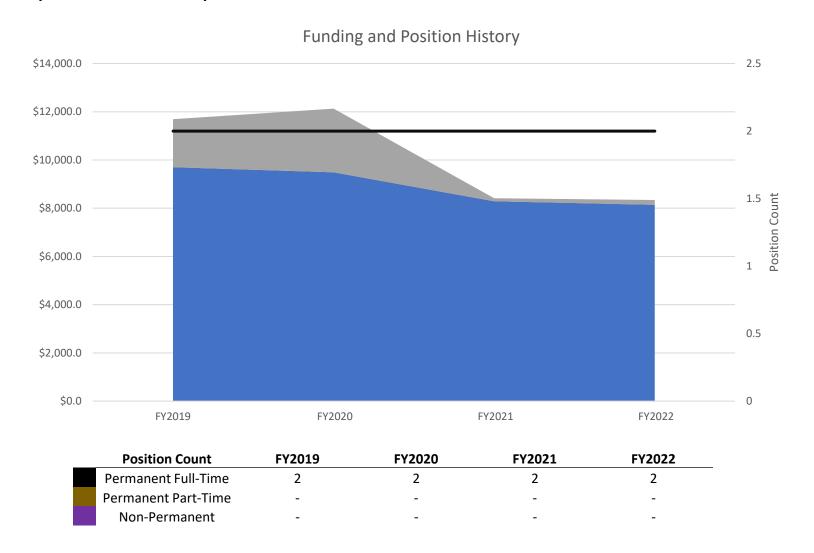

Budget Component: Early Learning Coordination

- > Provide support services and grants that provide locally designed comprehensive child development programs encompassing all aspects of a child's development and learning, with a focus on school readiness
 - Programs include: Head Start and Early Head Start Grants, Best Beginnings,
 Parents as Teachers
- > FY2022 Governor's Budget Changes from FY2021
 - \$2.0 (\$1.1 UGF, \$0.9 Fed) Contractual Salary Adjustments
 - (\$75.0) UGF reduction in supply costs due to virtual meetings and conferences
 - Net \$0.0 Change (\$75.0 Fed, (\$75.0) UGF) adjust funding source for an Education Specialist II position





Budget Component: Early Learning Coordination

- > Head Start and Early Head Start Program
 - Federal program that promotes school readiness of children ages birth to five from low-income families
 - Each Head Start program receives a 5-year federal grant from the U.S. Department of Health & Social Services, which includes 80% of their proposed project budget
 - Head Start programs are required to provide a 20% non-federal share
 - > The State provides \$6.8 million towards this non-federal share

> Parents as Teachers Program

- Collaboration with the State Department of Health & Social Services to offer children and their parents/caregivers home-based services during the early years of child development
- Grants are awarded through a competitive application process
- Since FY2018, DHSS has provided assistance for the program through a reimbursable services agreement with DEED

> Best Beginnings

- Partnership with DEED to promote early literacy information to help ensure all Alaska children begin school ready to succeed
- > Head Start Collaborative Grant (federally funded)
 - Funds the Head Start Coordinator position at DEED and supports Early Learning initiatives

Budget Component: Pre-Kindergarten Grants

- > Provide a voluntary, comprehensive, half-day preschool program for fourand young five-year old's (five-year old children who do not meet the cutoff date for Kindergarten entry) through school districts, based on the guiding principles and goals set forth in the Alaska Early Learning Guidelines
 - State Board of Education adopted revised <u>Alaska Early Learning Guidelines</u> in January 2021
- > The focus is improving standards, assessments, and accountability for early childhood education programs by developing active partnerships between families, schools, and community-based entities
- > No FY2022 Governor's Budget Changes from FY2021
