### **Synopsis: Proposed Regulations Allowing ATVs and Snow Machines on Roads**

Alaska has one of the nation's highest per-capita ownership rates of all-terrain vehicles (ATVs), off-highway vehicles (OHVs), snow machines, side-by-sides, utility terrain vehicles (UTVs), and all-purpose vehicles. These vehicles are extremely popular with Alaskans, affording them the opportunity to engage in hunting, fishing, and subsistence activities, as well as motorized recreation.

Arizona, Idaho, Montana, South Dakota, and Wyoming provide owners of all-purpose vehicles the option to make their machines street-legal and operable on public roads.

To provide Alaskans the greatest opportunity to safely and affordably travel throughout the state, the Department of Public Safety (DPS) and the Department of Administration (DOA) have proposed regulations that together would allow Alaskans to legally operate their ATVs or snowmobiles on roads with speed limits of 45 mph or less.

Vehicle owners would be required to follow all current applicable statutes and regulations while operating on roadways, including being properly licensed and insured. The proposed regulations also would require vehicles to be equipped with safety equipment—including headlights, brakes, mufflers, and brake lights—while operating on public roads. Local governments would be empowered to opt out of the provisions for roads within their jurisdiction.
