The Alaska Research Consortium (ARC) is writing in support of HCR 2 and the continued work of the Alaska Ocean Cluster on behalf of Alaska's blue economy. We understand and support the concept of the Alaska Ocean Cluster for our state and we are in discussions with the group about potential partnerships. The Alaska Ocean Cluster has a broad vision for the blue economies of Alaska.

The Alaska Research Consortium was formed in 2016 at a time when the University of Alaska was considering closing or repurposing the Kodiak Seafood and Marine Science Center (KSMSC). KSMSC is a perfect example of an "ocean cluster hub" for Alaska with its seafood processing pilot plant and a long history of seafood product development, including some of the best work in the country on fish and shellfish byproducts that are often discarded. ARC recently completed a project titled, "Alaska's Seafood Future" looking at the need for continued applied seafood research in our state, currently non-existent, due to lack of capacity funding. Partnering with the Alaska Ocean Cluster can lead to new, creative opportunities and collaborations to continue this important work.
