She has repeatedly voted against proposals that would benefit commercial fishermen, offering little to no reasons to back up her decisions. This was the case at the Upper Cook Inlet meeting in February of 2020.

One of the few exceptions of her voting for fishermen was at the Kodiak Finfish meeting in 2019 where she voted to support several proposals that solely benefited Chignik commercial fishermen over Kodiak fishermen. In Kodiak, Ms. Carlson-Van Dort did not fulfill common Board of Fisheries protocols by engaging with fishermen on both sides of the issue and voted strictly for Chignik fishermen that are also shareholders and directors of the Chignik Village Corporation, Far West, Inc. of which she is President. Kodiak fishermen and many others that attended the Kodiak Board meeting had never seen such blatant bias displayed by an Alaska Board of Fisheries member.

Currently four out of seven Board of Fish members are based in the Anchorage area. Israel Payton is in Wasilla, John Wood is in Willow, Gerad Godfrey is in Eagle River and Märit Carlson-Van Dort is in Anchorage. Having four out of seven board members from the same region shows an absence of diversity as well as lack of representation from coastal Alaska communities. Currently, only two members of the Board of Fish hail from coastal communities. Seafood from coastal communities contributes \$5 to \$6 billion in economic activity in Alaska each year and supports nearly 60,000 direct jobs and an additional 11,000 indirect jobs in Alaska. The seafood industry also pays approximately \$172 million in taxes, fees, and self-assessment to fund fisheries management each year. This revenue is more than four times the state general fund revenue used by the Commercial Fisheries Division (approximately \$38 million). Our industry is paying more than our fair share and we respectfully ask for balanced representation.

An ideal Board of Fish member would be fair and impartial towards user groups and rely on science, local user group expertise, and the Department of Fish and Game recommendations. 

RE: BOARD OF FISHERIES CONFIRMATION - Opposition to Carlson-Van Dort

Honorable Senators Revak and Micciche.

North Pacific Fisheries Association is an organization established in 1955, based in Homer, Alaska. Our members are Alaskan fishermen and crew that participate in fisheries from the Bering Sea to Dixon Entrance in Southeast. Our membership is dependent on decisions made by the Board of Fisheries for their livelihoods and the coastal communities they live and fish in are dependent on those decisions as well.

We oppose the confirmation of Marit Carlson-Van Dort to the Board of Fisheries.

Ms. Carlson-Van Dort was chosen to fill a commercial fishing seat on the Board of Fisheries and has demonstrated repeatedly that the only support she is willing to show for commercial fishermen is for Chignik where she has familial and community ties as the President of Chignik Village Corporation, Far West, Inc.

We have strong concerns about her conflicts of interest, but also her ability to come to the table with an open mind and receive public input. In the 2020 Upper Cook Inlet meeting, Ms. Carlson-Van Dort did not provide justification for her support of sport proposals over commercial fishing and in Kodiak she voted solely with Chignik proposals written by fishermen who are shareholders and board members of the Chignik Village Corporation, Far West, Inc. Several of the proposals submitted at that meeting came from her first cousin. Her uncle transferred his Chignik salmon permit just weeks before the Kodiak meeting. This removed a technical conflict of interest for Ms. Carlson-Van Dort, allowing her to vote on Chignik issues. In her justification of her vote, she read from prepared comments and said "we" on the record, indicating that she was not voting as a Board of Fish member, but as others would have her vote in support of Chignik, in spite of overwhelming public opposition in the form of comment letters and public testimony from Kodiak fishermen, Native Corporations, and concerned members of the public around the Kodiak Archipelago.

Commercial fishermen have found it difficult to access to Ms. Carlson-Van Dort as a member of the Board of Fisheries. If willing to talk she appears to agree on an issue, but then votes in opposition without justification of her new position. This leads many to conclude that she is not open-minded, and her voting record demonstrates that the only commercial fishing interests she's willing to entertain are her own, Chignik's. For these reasons, we respectfully ask that you oppose the confirmation of Marit Carlson-Van Dort to the Board of Fisheries.

I was born and raised in Homer to fishermen and seafood restaurant owner parents and have been a resident since then. I now live on Kodiak Island where I work as a fisheries anthologist studying fisheries access and well-being within fishing communities. I also own and operate a small-scale fishing vessel with my husband, who was also born and raised in Alaska. We sport, commercial, personal use, and subsistence fish for salmon and other species as well. Fishing is central to our livelihood and cultural identity.

I strongly oppose Ms. Carlson-Van Dort for reappointment to the Board of Fisheries (BOF). If I only read about her on paper, aside from her Pebble connection, I may be inclined to support her as I would like to see more Indigenous and female representation on this Board. However, I have had firsthand experience watching her function as a Board member at the 2019 Kodiak meeting and there is absolutely no way I can support her after assessing her in that role. I think that Board of Fisheries members should be held to a very high standard and their character and integrity mean more to me than a demographic headcount.

I was honestly shocked while witnessing Ms. Carlson-Van Dort's behavior at the most recent Kodiak meeting. It quickly became clear to me and others as the meeting unfolded that she arrived in our community with her mind made up about her votes on certain proposals, some written by her family members and all of which benefited shareholders of the Far West Inc. Chignik Village Corporation that she's President and CEO of. This inappropriate conflict of interest should have been remedied at the time and while I believe Board members should be able to share their knowledge and perspective, there is no way she should have voted on those proposals. Perhaps even more offensive was that I felt she was not interested in and edged on being hostile in body language and comments towards Kodiak community members sharing their testimony. Getting up to testify is really intimidating and the Kodiak community showed up to protect our region, yet it felt like our words were lost on her. At the Cook Inlet meeting, she portrayed a similar attitude towards commercial fishermen and their families when she voted in favor of sport fish interests. The kind of behavior she has exhibited to date erodes trust in the public process so foundational to the BOF.

The BOF is one of the most important governmental bodies that impacts my family, friends, and regional community. As anyone connected to commercial fishing knows it is a 24/7 lifestyle and not just a job we get to leave at 5pm. Commercial fishing livelihoods teach cultural values and environmental stewardship lessons and we deserve equitable treatment. Alaska needs a balanced

BOF with diverse geographic and stakeholder representation. What we do not need are Board members with questionable ethics and a set agenda to accomplish without public input and scientific data, and unfortunately, Ms. Carlson-Van Dort showed the public what kind of a Board member she is. Furthermore, I'm not supportive of having BOF members with ties to the Pebble Limited Partnership and she was Director of Regional Affairs for the five years leading up to her BOF appointment.

After waiting many hours I was able to testify at the Joint House Fisheries and Resources Committee, but do not think I will able to attend and testify at the Senate Resources Committee on Friday, April 16th. Please take this letter as my personal testimony and I'm asking you to oppose Ms. Carlson-Van Dort's confirmation to the Alaska Board of Fisheries.

I own and operate a commercial fishing business with my wife in Kodiak and am a second generation fisherman born and raised here. We sport, commercial, personal use, and subsistence fish. I am writing to voice my **concern and opposition to** the confirmation of Ms. Carlson-Van Dort to the Alaska Board of Fisheries. After participating in at the last Kodiak Board of Fisheries meeting I was dismayed by the lack of moral compass as a Board member that she displayed by not recusing herself from voting on Chignik/Kodiak issues. Multiple proposals were submitted by her family members and a last minute family transfer of a Chignik salmon seine permit being the only thing that narrowly allowed her to vote is questionable at best and at worse a direct ethical violation of the public's perception of Board behavior. It is inappropriate for any Board member to come into a meeting with a clear pre-determined agenda and seemingly refuse to take into account public testimony and science and it was clear to me that was the case with Ms. Carlson-Van Dort when I saw her at that meeting. To have her confirmed would severely erode the public trust in the Alaska Board of Fisheries as an institution.
