#### FISCAL NOTE ANALYSIS

## STATE OF ALASKA 2021 LEGISLATIVE SESSION

#### **Analysis**

The bill would provide Alaskans with the right to know when businesses are collecting their personal information, the right to learn what information businesses have previously collected about them, the right to request that businesses delete any personal information that has been collected, and the right to prevent businesses from selling their personal information.

The bill also prevents businesses from disclosing the personal information of children under the age of thirteen to third parties and prevents businesses from disclosing the personal information of minors above the age of thirteen without the consent of a parent or guardian.

Further, the bill requires data brokers—businesses that do not have a direct relationship with a consumer, but nonetheless collect and sell the consumers' personal information—to register with the Department of Commerce, Community, and Economic Development (DCCED) and for DCCED to make specific information on registered data brokers available online for consumer access. The Business Licensing database and the Corporations, Business, and Professional Licensing website will require minor adjustments to accommodate data brokers registrations. Those changes will be incorporated into planned system changes and will not require additional expenditure authority.

If the bill passes the following expenses will be incurred: Services: \$2.7 (legal costs to amend regulations, printing, and postage in first year)

Business licensing at the Division of Corporations, Business, and Professional Licensing is funded by General Fund/Program Receipts fund source 1005 GF/Prgm (DGF). Business licensing fees are set per AS 43.70 and revenue in excess of authorized budgeted expenses reverts to the State of Alaska general fund.
