## CS for HB 164 Version I

## Summary of Changes

Pages 1-2, Lines 12-3: Amends the short title.

**Page 2, Lines 4-12:** Inserts AS 14.03.040, Day in session, and clarifies the length of a regular school day for grades 4 through 12.

Page 2: Section 3 of CS HB 164 v. I aligns with Section 2 of HB 164 v. B.

Page 2, Lines 24-28: Remove revisions made in the above section.

Pages 2-3, Lines 29-10: Section 5 of CS HB 164 v. I aligns with Section 3 of HB 164 v. B and amends the section to ensure parents/guardians of students also receive a list of resources in adult literacy.

Page 3, Line 11-22: Removes revisions made in the above section.

**Pages 3-5, Lines 23-2:** Section 8 of CS HB 164 v. I aligns with Section 4 of HB 164 v. B and inserts new requirements regarding reporting on district administrative employees.

Pages 5-6, Lines 3-13: Removes revisions made in the above section.

**Page 6, Lines 14-21:** Inserts new provisions requiring districts to post statistics relating to administrative employees.

**Pages 6-7, Lines 22-1:** Inserts AS 14.03.080 and ensures a child under school age may attend a public school.

Page 7, Lines 14-17: Reinstates an existing statute pertaining to the age a child may start school. This section will become effective June 30, 2034.

Pages 7-8, Lines 18-16: Section 13 of CS HB 164 v. I aligns with Section 7 of HB 164 v. B.

**Pages 8-10, Lines 17-30:** Section 14 of CS HB 164 v. I aligns with Section 8 of HB 164 v. B and amends the early education grant program structure and eligibility.

Pages 10-13, Lines 31-15: Section 15 of CS HB 164 v. I aligns with Section 9 of HB 164 v. B.

Pages 13-16, Lines 16-1: Removes revisions made in the above section.

Pages 16, Lines 2-5: Section 17 of CS HB 164 v. I aligns with Section 10 of HB 164 v. B.

Page 16, Lines 5-16: Section 18 of CS HB 164 v. I aligns with Section 11 of HB 164 v. B.

Page 16, Lines 17-28: Removes revisions made in the above section.

**Pages 16-18, Lines 29-4:** Section 20 of CS HB 164 v. I aligns with Section 12 of HB 164 v. B with minor revisions.

**Page 18, Lines 5-20:** Amends AS 14.07.168 and directs DEED to report on the virtual education consortium established under AS 14.30.800.

Pages 18-19, Lines 21-6: Removes revisions made in the above section.

**Page 19, Lines 7-16:** Section 23 of CS HB 164 v. I aligns with Section 13 of HB 164 v. B.

Page 19, Lines 17-24: Encourages districts to make cooperative agreements.

**Pages 19-20, Lines 25-11:** Provides \$3,000,000 each fiscal year for early education program grants.

Page 20, Lines 12-17: Removes revisions made in the above section.

**Pages 20-21, Lines 18-8:** Revises statutes regarding unreserved fund balance carry over for school districts.

Page 21, Lines 9-25: Section 29 of CS HB 164 v. I aligns with Section 16 of HB 164 v. B.

Pages 21-22, Lines 26-12: Removes revisions made in the above section.

**Pages 22-23, Lines 13-5:** Section 32 of CS HB 164 v. I aligns with Section 18 of HB 164 v. B. Changes are repealed on June 30, 2034.

Pages 23-24, Lines 6-1: Amends AS 14.20.020.

Page 24, Lines 2-9: Section 34 of CS HB 164 v. I aligns with Section 19 of HB 164 v. B.

**Pages 24-38, Lines 10-23:** Section 35 & 36 of CS HB 164 v. I aligns with Section 20 of HB 164 v. B with minor revisions.

Page 38, Lines 24-27: Inserts a definition for "culturally responsive."

Pages 38-39, Lines 28-2: Section 38 of CS HB 164 v. I aligns with Section 21 of HB 164 v. B.

**Pages 39-40, Lines 3-25:** Repeals statutes mentioned above and establishes transition and applicability language. These sections also establish a comprehensive report that must be submitted to the 38<sup>th</sup> Alaska State Legislature.
