Analysis

This bill amends AS 10.06 to permit virtual meetings for shareholders of business and professional corporations, and AS 10.20 to permit virtual meetings for members of nonprofit corporations.		
There is no anticipated fiscal impact to the Division of Corporations, Business, and Professional Licensing.		
Business licensing in the Division of Corporations, Business, and Professional Licensing is funded by General Fund/Program Receipts fund source 1005 GF/Prgm (DGF). Business licensing fees are set per AS 43.70, and revenue in excess of authorized budgeted expenses reverts to the State of Alaska general fund.
