## **Analysis**

HB 132 will broaden the available work opportunities of youth employees, allowing them to work longer in the extended daylight hours. It will allow 16 year old youth to take up employment opportunities without the written approval of the Wage and Hour office. It will further allow adult relatives to hire their own dependents to work within the business owned and operated by the adult relatives without having to acquire a work permit.	
This legislation is not expected to have a fiscal impact on the department. The costs to the division should be de minimis and do not require a change to the current proposed budget.
