**FOR AN ACT ENTITLED**

**"An Act relating to sport fishing, hunting, and trapping licenses and identification cards; and providing for an effective date."**

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

**\* Section 1.** AS 16.05.340(a)(17) is amended to read:

(17) Waterfowl conservation tag ..... 10

(A) A person may not engage in waterfowl hunting without having the current year's waterfowl tag in the person's actual possession, unless that person

(i) qualifies for a \$5 license fee under (6) of this subsection;

(ii) is a resident under 18 years of age;

(iii) is 60 years of age or older and is a resident;

(iv) has an identification card issued [IS A DISABLED VETERAN ELIGIBLE FOR A FREE LICENSE] under

**AS 16.05.400(b)** [AS 16.05.341].

(B) The Board of Game shall by regulation exempt the requirement of a waterfowl conservation tag for waterfowl hunting in areas of the state not likely to benefit from programs described in AS 16.05.130(b)(2) - (4).

\* **Sec. 2.** AS 16.05.340(a)(23) is amended to read:

(23) Resident anadromous king salmon tag ..... 10

A resident may not engage in sport fishing for anadromous king salmon without having the current year's anadromous king salmon tag in the resident's actual possession, unless that person

(A) qualifies for a 50 cent license fee under (1) of this subsection;

(B) is under 18 years of age;

(C) is 60 years of age or older and has been a resident of the state for at least one year;

(D) **has an identification card issued** [IS A DISABLED VETERAN ELIGIBLE FOR A FREE LICENSE] under **AS 16.05.400(b)** [AS 16.05.341]; or

(E) qualifies for a \$5 license fee under (6) of this subsection.

\* **Sec. 3.** AS 16.05.341 is amended to read:

**Sec. 16.05.341. Free license for [DISABLED VETERANS AND] active members of the Alaska National Guard and military reserves.** A person may receive a resident hunting, **trapping,** and sport fishing license under **AS 16.05.340(a)(6)** [AS 16.05.340(a)(5)] without charge if the person

[(1) HAS BEEN DISCHARGED FROM MILITARY SERVICE UNDER HONORABLE CONDITIONS, IS ELIGIBLE FOR A LOAN UNDER AS 18.56.101, AND IS CERTIFIED BY THE UNITED STATES DEPARTMENT OF VETERANS AFFAIRS AS HAVING INCURRED A 50 PERCENT OR GREATER DISABILITY DURING MILITARY SERVICE;

(2) SERVED IN THE ALASKA TERRITORIAL GUARD, IS ELIGIBLE FOR A LOAN UNDER AS 18.56.101, AND INCURRED A 50

1 PERCENT OR GREATER DISABILITY WHILE SERVING IN THE ALASKA  
2 TERRITORIAL GUARD; OR

3 (3)] is an active member of the

4 **(1)** [(A)] Alaska National Guard;

5 **(2)** [(B)] United States Army reserves;

6 **(3)** [(C)] United States Air Force reserves;

7 **(4)** [(D)] United States Navy reserves;

8 **(5)** [(E)] United States Marine Corps reserves; or

9 **(6)** [(F)] United States Coast Guard reserves.

10 \* **Sec. 4.** AS 16.05.400(b) is amended to read:

11 (b) Upon request, and without charge, the commissioner shall issue a sport  
12 fishing, hunting, or trapping identification card to a resident who

13 **(1)** is 60 years of age or older;

14 **(2) has been discharged from military service under honorable**  
15 **conditions, is eligible for a loan under AS 18.56.101, and is certified by the United**  
16 **States Department of Veterans Affairs as having incurred a 50 percent or greater**  
17 **disability during military service; or**

18 **(3) has served in the Alaska Territorial Guard, is eligible for a loan**  
19 **under AS 18.56.101, and incurred a 50 percent or greater disability while serving**  
20 **in the Alaska Territorial Guard** [THE COMMISSIONER SHALL ISSUE A

21 PERMANENT IDENTIFICATION CARD WITHOUT CHARGE TO A PERSON  
22 WHO QUALIFIES BY AGE AND RESIDENCE AND WHO COMPLETES THE  
23 FORMS REQUIRED BY THE COMMISSIONER FOR IMPLEMENTATION OF  
24 THIS SUBSECTION. A PERSON WHO IS ISSUED A PERMANENT  
25 IDENTIFICATION CARD UNDER THIS SUBSECTION MAY NOT SPORT FISH,  
26 HUNT, OR TRAP WITHOUT HAVING A VALID IDENTIFICATION CARD  
27 ISSUED UNDER THIS SUBSECTION OR THE APPROPRIATE LICENSE IN  
28 POSSESSION].

29 \* **Sec. 5.** AS 16.05.400 is amended by adding a new subsection to read:

30 (c) The commissioner shall issue a permanent identification card without  
31 charge to a person who qualifies under (b) of this section and who completes the forms

1 required by the commissioner for implementation of (b) of this section. A person who  
2 is issued a permanent identification card under (b) of this section may not sport fish,  
3 hunt, or trap without having a valid identification card issued under this section or the  
4 appropriate license in possession.

5 \* **Sec. 6.** This Act takes effect January 1, 2022.
