# **BUDGET ACTION:**

The Senate Finance Budget Subcommittee for the Department of Environmental Conservation held two meetings with the Department and analyzed all the Governor's budget transactions, including amendments. The following are the budget highlights.

# **Governor's Budget Request:**

The following Governor's budget requests were **<u>not</u>** accepted:

- 1. Item # 1 and item # 8 on the Budget Action Sheet are related, they are technical adjustments:
  - The committee did <u>not</u> accept either transaction;
- 2. Item # 6 on the Budget Action Sheet is for the reduction of -\$692.7 in the Spill Prevention and Response appropriation/allocation and the associated five positions:
  - The committee did <u>not</u> accept the transaction; and,
- 3. Item # 9 on the Budget Action Sheet was an increase of \$230.0 of Oil/Haz funding for the Spill Prevention and Response appropriation/allocation:
  - The committee did <u>not</u> accept the transaction.

#### Sub-Committee Additions, Reductions and Changes:

The committee did *not* have any additions, reductions, or changes in committee.

#### **Position Changes:**

The committee reviewed the following position changes as requested by the Governor:

- 1. Item # 3 on the Budget Action Sheet deletes three permanent full-time positions in the Administration appropriation/Administrative Services allocation; and,
  - The committee **did** accept the transaction.
- 2. Item # 6 on the Budget Action Sheet deletes five permanent full-time positions in the Spill Prevention and Response appropriation/Spill Prevention and Response allocation:
  - The committee did <u>not</u> accept the transaction.

#### **Organizational Changes**

There were no structural or organizational changes requested in the Governor's FY22 budget.

#### Intent Language

The committee *did* accept the two "Conditional Language" sections that allow FY21 unexpended/unobligated balances to be carried forward into FY22.

The committee did <u>not</u> accept the Intent Language submitted by the House Finance Budget Subcommittee.
