I am writing today to share my concern over the appointment of Abe Williams to the Alaska Board of Fish. Greetings committee members,

Attached you will find my comments regarding the appointment of Abe Williams to the Board of Fisheries. My concerns related to this appointment, and the concerns of the members of the organization that I represent, are included in this document. What is not included and is necessary to elaborate here, is my dismay as a member of the public attempting to participate in this public process. I would like to share my concerns over the various barriers that have prevented my ability to address you today, and a little bit about this experience:

I live in Sitka which is one of many rural communities where the Legislative Information Office is currently shut down for committee hearings due to the COVID pandemic, and is currently not facilitating public testimony. Normally I would utilize this option because I know for sure that if I go through the LIO I will be acknowledged, and that I will be given an opportunity to be heard. I also know that I, as well as others will be supported in our participation in these hearings. LIO access is especially important in rural communities for these reasons as well as the reasons of the access to the technology to participate at all. Without that access the only option is to call in and wait on the line for your opportunity to speak. That is if you are lucky enough to have phone access or service and a decent connection.

This all began last Friday. I called in as did many others, and less than a dozen folks were given the opportunity to speak. It was then decided that the hearing would continue on Monday. So today I called back in and was told there was no way to connect me due to the fact the phone lines were full and the state's phone line system could not accommodate all the members of the public that were attempting to participate. I was then told that I should just try to call back every ten minutes until maybe a line opens up. After three attempts at calling back, I was told they were no longer accepting callers. I cannot express how frustrating it is to spend so much time navigating all of this to not even be given the opportunity to speak. What an awful experience to put the legislative support staff through as well. I cannot be the only one that went through this experience, and it is hard not feel outright silenced.

The message that was sent today is that this committee is not actually interested in public input, or interested in providing an opportunity for the general public to be heard. When issues are gaining attention, shutting down public participation does nothing but increases public outrage and reduces trust. Actions like this reduce trust in this whole process and in this system- and more importantly it causes people to question their trust in you as individuals, and your ability to represent the people of Alaska. These things may seem small but there are larger ramifications to these actions. There needs to be a better way forward and the systems need to be set up in a way that it provides the service to the public that it is meant to provide. Today was disappointing, I hope things are handled differently in the future for myself and for the rest of the people that live in this great state of Alaska.
