## FISCAL NOTE ANALYSIS

BILL NO. SB 45

### Analysis

SB 45 aligns the minimum age in Alaska to purchase tobacco products, electronic smoking products, or products containing nicotine with 21 U.S.C. Sec. 387f(d) as amended by PL 116-94, December 20, 2019.

The Division of Corporations, Business, and Professional Licensing (CBPL) does not anticipate fiscal impact from this legislation.

Business licensing at CBPL is funded by General Fund/Program Receipts fund source 1005 GF/Prgm (DGF). Business licensing fees are set per AS 43.70, and revenue in excess of authorized budgeted expenses reverts to the State of Alaska general fund.
