SUBJ: Renewal No. 1 of the Lease for Fairbanks Office Space
The original lease agreement between the Legislative Affairs Agency and Alaska USA Federal Credit Union for office space in Fairbanks, Alaska, was for a five-year term that began August 1, 2016 and terminates July 31, 2021. There are five lease renewals available under the lease agreement, each for a one-year period. We have not exercised any of the renewal options.

The initial five-year term of the lease expires on July 31, 2021. The Legislative Affairs Agency would like approval to proceed with Renewal No. 1 for the period August 1, 2021, through July 31, 2022.

If Legislative Council approves Renewal No. 1, this will leave four (4) one-year renewal options of the lease available before we must issue an RFP or conduct a lease extension.

This lease renewal exceeds $\$ 35,000$ in one fiscal year; therefore, Legislative Council's approval is required.
