I'm looking for honesty in the budget that gets offered for the next session.

If you want new cuts, please have the courage to tell us exactly what those cuts are and what the results will be. I don't like the budgets I'm seeing that allude to "additional cuts" or "new revenue" without specific proposals. What additional cuts? What new revenue? Without those details it's not a budget plan it's a fantasy.

We've been playing that game for years, and that's what has caused us to blow through billions in savings. If there were easy cuts to be made, we would have made them. Big cuts are essentially off the table unless you can **show me the money** -- and the political will to get it done.

So. When you propose a budget, bring it back down to earth. If you're proposing cuts or new revenue you need to explain exactly what they are or it's not a budget.

I run a manufacturing business in Anchorage for a small Alaska Native Corporation.

We manufacture polymer-modified asphalt for road construction. The recent cuts to the construction budget have hit us hard.

Our current transportation budget is about 1/4 of the traditional transportation budgets. As a result the profitability of this business is down, and I was unable to hire back half of my crew. Compared to two years ago we have 1/4 of the work.

Not only have those cuts cost Alaskans 6,000 jobs (according to ISER), but they have also cost us transportation money from the Federal Government. The federal match on transportation spending is 90% compared to our 10%. Keeping transportation spending in the budget should be a no-brainer. Please restore the transportation funding. It would make a big difference for hard-working Alaskans, our roads desperately need it, and it would infuse federal cash into our local economy.

I would support an income tax but not a sales tax, which would hurt the poorest and most rural Alaskans the most.

Members of the Fiscal Policy Working Group,

I'm writing to share my vision for fiscal stability for the State of Alaska. My name is Tyler Watson, resident of Anchorage (HD27), and I'm representing myself.

My number one priority for the legislature is to achieve a long term fiscal solution that solves our structural issues and allows the legislature to move forward on issues other than the PFD and budget fights every year. I think this can be achieved in a variety of ways, but with one common thread. All Alaskans have to work together and share in the cost of operating the state government. For me, this could be achieved in any number of combinations of the following:

1. A broad based tax (income: progressive and captures out of state workers, sales: more regressive, but captures tourist dollars)
2. Reform of oil tax credits and/or increase oil taxes
3. A strict adherence to the POMV (5%), and set the PFD to set percentage of the POMV.
4. Annual evaluation of state programs to find waste, inefficiencies, unfilled positions, etc to cut while protecting constitutionally mandated programs and programs that lookout for Alaskans in need.
5. State spending limit, that changes in accordance with inflation and population growth and has exceptions for emergency spending.

I'm agnostic to what the exact numbers or percentages are (aside from a sustainable POMV) as long as the solution allows for enough funding to pay for what we need and end the ongoing debate about PFD size.

Several plans like this have been brought forward before, Governor Walker proposed parts of this, Senator Micciche has spoken of the need to go "all in", and we've heard great ideas from this session's Ways and Means Committee. I hope your committee is able to come up with a new bold vision for our fiscal situation.

Dear Fiscal Policy Committee,

My name is Marcy Sowers. I was born in Juneau, AK. I currently live in Wasilla. I am providing this testimony voluntarily on my own behalf. For years we have called in public testimony about the criminal theft by the majority legislature and willful ignorance of our state statute regarding the PFD. The legislature has committed felonious theft of the people's PFD, ***year after year.***

If any "regular" (read peon, aka your constituents) person in this state purloined the amount of money the Legislature has each year, they would likely be tried and convicted with a felony charge!

The legislature ***should*** be upholding the law, the current statute. But ***no***—we have seen the legislature do the opposite of what their job description is. Nor are you representing the people, you are bound and obligated to special interests. It's as though the voters' voice doesn't matter to you. You obviously don't think much of our voice—we elected a Republican majority which you managed to subvert. We primaried people who voted against the will of the people. (And we will do that again!) We were successful! (We will succeed again!) Despite our clear messaging -you managed to ignore the loud and clear voice of the People - AGAIN!

We have been living in dire straits amid the economic "cluster-mess" of the pandemic. We have Alaskan families wondering how they will afford heat this winter or drive to work given the Biden administration's historically high oil/gas prices. We have crushing effects: of covid on tourism, the Biden administration policy on oil/gas leases, the Biden administration policy on our natural resources, the effect of the pandemic on education and our children.

Moreover—we have the Alaska legislature not standing up to make improvements or progress on these issues. If you spent as much time on the real problems—instead of the inordinate amount of time spent on partisan power plays, not addressing issues to create a budgetary crisis or trying to circumvent the as-written Alaskan statute on the PFD—we'd have made significant progress towards improving the laundry list of problems in our state—and we wouldn't even need a special session!

We have asked for a full PFD, repayment of the PFDs stolen since the legislature and Walker admin first took it, we asked you to cut the size and scope of monstrous and bloated Alaskan government. We asked for a balanced budget. ***You ignored it.***

We have asked you to protect the PFD in its current statutory formula. ***You ignored it.***

We are all writing or calling in again, now to provide public testimony telling you we need you to do your job. Listen to your constituents, to obey the current law, the law that has been on the books for years. ***You are not above or outside the law. Our economy, families all could desperately use the influx of cash. The notion of a \$500.00 check is a slap in the face of every Alaskan.***

Contrary to the belief of some in the legislature *we* best know how to allocate our resources. We do not need you to decide for us. In fact we have spoken many times—full PFD, balanced budget, cut the bloated government, incentivize private industry/small businesses. One might start to think it is you-legislators- who need help in managing things-because clearly you have not been able to “represent” your constituents. The time for selective representation of one political party, union leaders, special interest lobbyists needs to end.

It’s long past time for you all to uphold the law. If you fail to protect the law, the PFD statute/historical formula-(and I do *not* mean the legislature’s interpretation of the law/formula from the past few years) and do your job, once more you are no better than criminals committing larceny or fraud. Do your job-obey the law. We ask criminals to pay restitution. Repayment of withheld PFDs is no different. It is what is called “justice”. We are tired of this ridiculous battle year after year, but our weariness does not mean you’ve worn us down; the legislature has just made us more angry and incentivized more people to do their civic duty and run to replace those of you who fail to do your jobs and *uphold the law*.

*Thank you to the amazing Senators and Representatives who actually listen to their constituents. These legislators are not “obstructionists” as some of you would like to paint them. They are the only ones with spine enough to wade through our “swamp” - the Alaskan political Muskeg.*

*To them and the others who are contemplating the notion of ignoring the special interests. Who want to do the right thing, for their constituents, I say:*

You may remember when Alaskans voted to move the Capitol and then voted not to when they became aware of the cost. We are in a similar situation today with some Alaskans wanting a big PFD but not wanting (your survey) the taxes that would go along with it. I have always supported the idea of the PFD but I have never been in favor of spending down our capital to keep the PFD high. We simply cannot have it both ways.

The final budget has to be a combination of actual income, cuts, and revenues. It cannot be based on what might be proposed for the future or what good might happen in the future. Bad might happen like another crash in oil prices (we have been there more than once), a big earthquake (think 1964), or a bad stock market. I do not have the date(s) on hand but I do know that there has been at least one period when the Dow Jones was essentially flat over 10 years. We have to deal with reality today.

Leave PCE alone as an endowment. It should not be any part of these budget discussions. If the governor or legislators want the PCE to be a part of the annual budget where it can be (will be) cut, they should just say as much. I support PCE while living in a urban area. When I lived in a bush village years ago we had a light plant (generator) that ran on gasoline so we depended on Coleman stoves mostly for light. The generator kept batteries charged for our required daily contact with Fairbanks and another village. Our radio was part of the old WAMCATS system. Those were the days of relatively cheap gasoline but nobody else in the village had any electric power. They could not afford it. The situation today is different but people on the road system still have a built in advantage.

In regard to additional cuts that some legislators want, I would like them to tell us what they want cut and why. Most legislators today from both major parties seem to think we have cut enough and I agree. We are now spending something like 20% more on corrections than we are our university system. I used to live in Sitka before the ferry system even started so I have some understanding about how those folks feel about their water highway system.

I support PCE and a realistic balanced budget and as big a PFD as we can actually afford without spending down our capital. Please deal with today's reality. Thank you.

With regards to the state budget, I am strongly urging the Alaska Legislature to fully restore the Power Cost Equalization (PCE) and back to its Endowment Fund. I am one of the many cooperative members of the 58 villages of the Alaska Village Electric Cooperative that depend on PCE to pay for my monthly electric bills. Without PCE, I do not know how I could have survived during the cold winter months. At the current .50 cents per kilowatt, it is still four times higher than what urban households pay with cheap electricity. Failure to restore the PCE, will be a breach of agreement between the urban and rural governments that was made in the early 1980's through the former rural and urban legislators. Furthermore it will politically re-divide the rural and urban relationship.

My other concern is the 17 million dollars that was cut in the medicaid program that is impacting the poor people in the rural and urban communities. That should also be restored.

The Alaska Performance Scholarship and the Alaska Education Grant program funds need to be restored back to its original funding. The University System has already suffered from Governor Dunleavy's prior cuts and without the full funding of ACPE, it is going to have a huge impact in the state education system.

I am not concerned about the permanent fund dividend and with the needless debate going on with the permanent fund dividend, it is wasting your time on finishing the state budget. First things first is a priority. Governor Dunleavy is making it sound that people are doomed to die if they don't get the \$5,000 dividend. A lot of work needs to be done with PFD and it can be postponed until the next legislative session.

Thank you for this opportunity to give my input on our fiscal crisis. I have lived and worked here since 1974, when I moved here after college, following the footsteps of my great-grandfathers and grandparents.

First, I do not recall that I voted on ending the state income tax and leaving the state to rely solely on the oil revenues. I do recall that the current formula is nothing like what Governor Hammond intended, and that it was the lawsuit brought by the Zoebel's that resulted in everyone getting an equal share of dividends which further drained the fund much more than with the original formula, and a whole generation of Alaskans grew up not paying anything towards the upkeep of our state and instead getting paid for living here. Incidentally, many high-paid oil workers paid no taxes and left the state giving nothing in return.

Somehow many Alaskans have decided that the dividend portion of the fund should be set in stone. I humbly disagree. As cuts to services continue we are at the bottom of many indicators of a healthy state: 47% for economic well-being of children (KidsCount 2021), 49<sup>th</sup> in adult mental health (MHA), and 50<sup>th</sup> in the nation for overall health care, access, and outcomes (2016 WalletHub) and 49<sup>th</sup> out of the "Best States to Live in 2021" (WalletHub).

We can no longer afford to pay out large dividends and expect to rely solely on the fund for operating our state. The party is over and has been for some time.
