13 based background check that is substantially similar to a background check required under 7
14 AAC 10.910(a) is conducted as part of the hiring process; and

15 (3) not later than July 1, 2022, obtains a background check from the
16 Department of Health and Social Services for each person hired by the provider between the
17 effective date of this Act and July 1, 2022."
