FISCAL NOTE ANALYSIS

BILL NO. SB 43

Analysis

This bill proposes changes to new campaign disclosure reporting requirements enacted through the passage of Ballot Measure 2 in the 2020 general election. The measure will go into effect during the upcoming April 2021 Anchorage municipal election cycle and requires independent expenditure groups involved in candidate election activities to report to the Alaska Public Offices Commission (APOC) within 24 hours of receiving a contribution. It also requires the contributor to report within 24 hours of contributing to a group.

Provisions of the proposed bill would extend these same reporting requirements to independent expenditure groups and their contributors involved in ballot measure campaign activities. Operating under the new law during the Anchorage election cycle will provide further insight into the effect it will have on agency operations; however, at this time the APOC is unable to determine costs of implementing changes proposed in this bill. Therefore, APOC submits an indeterminate fiscal note.
