

Alaska Psychiatric Institute: Teamwork

- As of FY2020 API has maintained its core leadership
- Key positions hired at the end of FY2021
 - Medical Director March 2021
 - Director of Clinical Services March 2021
- Expanded clinical programming by filling vacancies and key positions
 - Chilkat adolescent unit opened May 2021
 - Expanded hours for clinicians to include more evening and weekend treatment
 - Updated and improved risk assessment services hospital wide
 - Assigned a social worker to assist in complex discharges

Workplace Safety

- Established a Workplace Violence Reduction Committee
 - Goal is to reduce incidents of harm and days away from work.
- Procured and implemented a violence risk assessment tool as a predictor of a patient tendency towards violence.
 - Staff attended training by the developer.
- Established monthly verbal and physical de-escalation skill development for patient facing staff
 - Scenario based practice
- Implemented expert review of actual incidents to provide feedback and coaching
- Implemented a process for routine access for peer support after incidents
 - Critical Incident debriefing is an evidence-based peer support team who are trained in helping individuals process feelings after a critical incident





Designated Evaluation and Treatment

DETs require psychiatric and inpatient hospital services.

There are three criteria for admission into a DET facility:

- 1. An individual has been determined to be mentally ill (as defined in AS 47.30.915), and
- 2. An individual presents a likelihood of serious harm to self or others, or is psychologically gravely disabled (as defined in AS 47.30.915), and
- 3. An individual cannot be treated in a lesser restrictive environment.

In addition to the state psychiatric hospital, the Alaska Psychiatric Institute (API), there are currently three DETs in Alaska:

- 1. Bartlett Regional Hospital 12 beds
- 2. Fairbanks Memorial Hospital 20 beds
- 3. Mat-Su Regional Medical Center 16 beds
