FISCAL NOTE ANALYSIS

Analysis

This bill will allow for the receipt of a state land voucher in lieu of a permanent fund dividend.

The Division of Public Assistance estimates there will be a one-time mailing to public assistance clients to notify them of the impact the land voucher could have on their eligibility for public assistance programs

The mailing costs associated with 170,000 letters are as follows:

5,000 sheets paper = \$60.0 $170,000/5,000 \times 60 = \2.0

Postage = \$0.50 per mailing x 170,000 = \$85.00

Envelopes = \$0.11 per envelope x 170,000 = \$18.8

Printing = \$0.20 per page x 170,000 = \$34.0

Total cost for one time mailing \$139.8
