"There was a slowing of contested hearings at the beginning of the pandemic, but then it picked back up to normal levels. If anything, more recently there seems to have been an uptick in contested hearings and I have observed an increase in workload for my paralegal as a result.

Higher [OCS] worker turnover results in an increase in work for us (my paralegal and I have to know things that we used to be able to ask the worker; my paralegal and I have to do increased communication with the client about the status, reports, petitions to terminate, trial prep, etc.).

Reviewing my calendar for the last year, it is common for me to have fifteen to twenty hearings in a week, plus a contested hearing, plus a mediation or other meeting (or several), in addition to giving the occasional training.

In addition to my hearings, trials, and meetings, I generated more than two hundred and fifty (250) written orders last year, along with an unknown number of motions, oppositions, petitions and other pleadings.

Despite my working very efficiently the current workload exceeds what I can do, and do well, in my allotted time. The sentiment from my coworkers, over and over, is that we're all in the same boat (my workload isn't special or unique) and that we're all doing the best we can but that it is taxing."

Retirement;



# Civil Division Multi-Year Appropriation




## STATE-OWNED NAVIGABLE WATERS

AFTER STATE MANAGEMENT ASSERTION




