My name is Desiree Cook and I am a Palmer resident with my husband and 4 kids. My husband works on the slope and the uncertainty of pending vaccine mandates over the last 12 +\- months had been very stressful. Thankfully, due to the SCOTUS ruling, he doesn't have to worry about choosing between his personal autonomy and feeding his family.

I am not in the same boat. I am going to graduate from UAA with my bachelors of science in nursing in May 2022 and the uncertainty of whether or not I will be employable due to turning down a vaccine for an illness I've recovered from twice weighs heavily on me.

All nursing theories throughout nursing school have taught that individual autonomy is to be respected, that the patient always has the right to refuse, and that the job of healthcare workers is to educate not force any medical treatment - this is called provided informed consent. Dear Senators,

I am an Alaskan family medicine physician. One of the things that makes healthcare in Alaska so great is that we have the freedom to practice the art of medicine, meaning unique and individualized care based on each person's goals and values. By allowing vaccine mandates and passports, not only would individuality be jeopardized, but also basic human rights and freedom. If there is risk, there must be choice. Not only do the currently available COVID-19 vaccines have known risks such as myocarditis, but the extent of risks such as blood clots, paralysis, and even death is unquantified. How then is it ethical to mandate such a vaccine if the vaccine itself does not prevent infection or transmission of the virus and is not current to the infection we are now facing? The COVID-19 vaccines only code for the spike protein of the original COVID-19 virus. The spike protein present in the omicron strain has at least 30 mutations in that one protein alone, rendering the vaccine virtually ineffective.

I have been actively treating COVID-19 since before the onset of the omicron variant and have seen vaccinated person after vaccinated person test positive for COVID-19 with symptoms that are largely indistinguishable from those who are not vaccinated. Thankfully a large percentage of our population now has natural immunity which is at least as effective if not more than vaccine immunity.

In sum, mandating the COVID-19 vaccines for all would strip the individualism and freedom that make Alaskans Alaskan, cause unnecessary injury and even death without choice for little to no benefit to our communities or workplaces.
