### FY2023 GOVERNOR BUDGET CHANGES

## Fund Change from UGF to General Fund/Program Receipts and Shore Fish Receipts - \$255.8 (DGF)



- Replace Unrestricted General Funds (UGF) with:
  - \$155.8 in General Fund/Program Receipts (GF/PR)
  - **\$100.0** in Shore Fish Receipts
- This fund change does **not** result in an increase in fees

#### Fund Change from Land Disposal Income Fund to UGF - \$962.9 (UGF)

- The Land Disposal Income Fund (LDIF) will be swept at the end of FY2022, and a reverse sweep was not included in the FY2023 budget
  - There will not be sufficient funding to cover anticipated expenditures based on projected FY2023 revenue collections and therefore this fund change ensures continuity of service

#### Amend Carryforward of General Fund/Program Receipts - \$5,000.0

- Increase the carryforward cap from \$3,000.0 to \$5,000.0
- FY2022 **\$545.0** fund change from UGF to GF/PR




### WHAT DMLW MANAGES

#### STATE OF ALASKA LAND BASE & OWNERSHIP



#### **Multiple Use Management of State Lands**

- DMLW manages 100+ million acres state-owned land, 65 million acres of tides lands and 34 thousand miles of coastline making them available on a sustained-yield basis for a variety of multiple beneficial uses.
- DMLW does not manage TLO, Parks or lands acquired by other agencies for specific purposes.
- DMLW's responsibilities include
  - Land acquisition;
  - Mining, land, and water use authorizations;
  - Area and Management plan development;
  - Land sales and conveyances;
  - Land stewardship
- DMLW has jurisdiction over the appropriation of the State's water resources, accounting for approximately 40% of the nation's stock of fresh water



## ASSISTING ECONOMIC DEVELOPMENT THROUGH AUTHORIZATIONS

- Thousands of jobs and millions of dollars in state revenue require authorizations for use of state land (surface and mineral estate), freshwater, and tidelands by DMLW
- DMLW currently has over 51,000 issued authorizations which assist in the development of local economies and support a variety of industries statewide
- DMLW assists in diversifying the state's economy thru authorizations involving in mining, hydroelectric power generation, hunting, fishing, guide-outfitter activities, aquatic farming, and other industries that depend on state land, and water to operate
- DMLW subdivisions, sale of state lands, and issuance of Municipal Entitlements assist in creating a tax base for cities and boroughs

• Ensures accurate fair market value is determined for land acquisitions, disposals,

leases or other management actions

- Gravel sales for road construction and private development

- Lodge sites and access for the tourism industry
- Lease set-net sites for commercial fishing and mariculture sites for the shellfish farming industry
- Support timber industry by authorizing necessary infrastructure
- Access for public and private entities across state lands and waters, including roads, power, telephone, and fiber optic

- Authorizes the use of state land for large- and small-scale mining through
  - Approval of Plans of Operations for Upland & Millsite Leases
  - 41,000+ mining claims for mineral exploration and development
  - 30 Coal Leases and 48 Mineral Leases
  - 87 Offshore Mining Leases
- Oversees statewide reclamation requirements
- Regulates reclamation and removes hazards from past mining operations to help protect public health or safety hazard











- Asserts RS 2477 rights-of-way




### REALTY SERVICES SECTION





- Acquire and secure clear title to land from the federal government, and other sources
- Issue clear title documents to the private sector, municipalities, and other government entities
- Responsible for fulfilling the State's land entitlement
- Maintain administrative records of state land ownership

## LAND ST

- Provides land stewardship of nearly 165 million acres of state land with the intent to keep the land unencumbered and available for public use
- Represents the interest of the state as the landowner in matters pertaining to contamination, spills, and abandoned and derelict vessels




- Determines boundaries of state lands, submerged lands and navigable waters
- Ensures the boundaries of lands conveyed to or by DNR are legal and protect the rights of the state and other adjacent landowners
- Ensures lands acquired by DNR are adequately described and state property interests are protected from loss to federal overreaching surveys
- Fulfills DNR's role as platting authority for all lands outside organized boroughs









## WATER RESOURCES SECTION & DAM SAFETY

- Manages and authorizes the beneficial use of water in Alaska regardless of land ownership, consistent with the public interest
- Provides hydrologic assessments for understanding the impact of water appropriations on surface watersheds and ground water aquifers
- Protects public safety by regulating construction and maintenance of state jurisdictional dams







# DMLW Sources Of Revenue Generation



- Generated \$33.1M in revenues to the state through authorizations for use of state lands and waters, royalty payments, and land sales
- The Division is a state revenue generator, producing an average of \$7 in revenue for every \$1 dollar of UGF appropriated to the Division
- Revenue generated through DMLW authorizations such as:
  - Mining Claim Payments
  - Land Sales
  - Leases
  - Easements
  - Permits
  - Material Sales
  - Temporary Water Use Authorizations
- In addition to generating revenue for the state, DMLW helps diversify local economies through resource and land use authorizations

# DMLW ACCOMPLISHMENTS SUPPORTING RESOURCE DEVELOPMENT

DIVIDO POR LAND EN

- Conveyed 41,677 acres out of state ownership in FY2021 to help support local economies
- DMLW's work to adjudicate water rights and temporary water authorizations generated over \$297.0 in revenue in FY2021
- Between October 2021 and January 1, 2022 the Mining Section staff reduced the backlog of new mining claims from 691 claims to 81 claims
- Updated DMLW policy to issue public easements for fiber optic projects resulting in a reduction of use fees to providers
- Aquatic Farm Lease Program Improvements
  - Expanded the aquatic farm program administration into the Southeast Regional Land Office
  - Coordinated with ADF&G and DEC to revise the Joint Agency Application

## DMLW AUTHORIZATIONS AQUATIC FARM LEASES UPDATE



- Participated in the creation of the Alaska Aquaculture Permitting Portal, a portal that outlines the necessary steps to receive state and federal authorization for an aquatic farm in Alaska.
- 75 aquatic farm leases authorized encompassing 1,178 acres
  - 39 Southeast, 27 Southcentral, 7 Kodiak, 2 AK Peninsula and Aleutians
  - 31 farms encompassing 763 acres culture kelp
  - In 2020 2021 a total of 37 leases issued





## CONTINUOUS PROCESS IMPROVEMENTS ACCOMPLISHMENTS

- Establish policy teams to develop statewide consistent procedure for processing permits, easements, leases and material sales
- 79% of permit applications completed within 30 days of receipt
- Creation of additional Over the Counter (OTC) permits
- Created a new public facing website for the Regional Lands Offices
  - Details the timelines and the process for permits, easement, leases and material sites,
  - Provides general information on state land to assist in education of the public on the processes and provide clarity
- Developing an online application portal

# Pending Legislation Supporting DMLW Mission

- SB 97/HB 120 State Land Sales and Leases
  - Leasing/sale of state lands deemed suitable for commercial development, within Qualified Opportunity Zones or in state determined commercial development areas
  - Statutes are modified to reduce restrictions on agricultural land to private ownership
  - Increase spending authority from the Land Disposal Income Fund for project development
- SB 133/HB 195 Remote Recreational Sites, Sales and Permits
  - Remote recreational cabin sites are included for permits, leases, and sales
  - Establishes the criteria and process for nomination of a parcel of a cabin site on land classified settlement or on vacant, unappropriated, or unreserved land
  - Establishes that a 10-acre parcel size may be staked
