The problem with using the PFD to fund government at the levels proposed by these bills is that it establishes a head tax which is one of the most regressive forms of taxation. I know there is discussion whether it is a tax, but (just as the Affordable Care Act was determined by the Supreme Court to be a tax) when the government is intentionally reducing the potential income of its citizens, it is a tax.

High income earners with small household size prefer this form of taxation—it results in less taxes than a flat or progressive tax for them. Unfortunately for Alaska, this is the case for most of the legislators and well-connected Alaskans and Outside influences. There is no motivation to talk about a better tax structure because they have the best option already (FOR THEMSELVES). I, like most Alaskans, want to keep the tax burden as low as possible, but we need to be honest about income and expenses.

A plan for taxation should spread the tax burden more evenly between all Alaskans. To tax low income families at a higher rate and dollar value over high wage earners is irresponsible.

A full statutory PFD is my stated preference. I also support a spending cap. I support a low flat tax with a sunset date when our fund reaches a certain balance that will provide an enduring endowment to fund government operations. Both of these bills place the burden on middle and low income earners to fund government.
