Dear Senators,

I support Senate Bill 156, sponsored by Senator Lora Reinbold, which would make vaccine mandates and so-called "immunity passports" unlawful in Alaska. Hello,

My name is Samantha Berg, I am an Acupuncturist/Chinese Medicine practitioner in Palmer, AK and I have been an Alaska Resident for over 28 years. My husband and I own Alaska Center for Acupuncture - our business has been in the Valley for over 17 years.

As a healthcare professional, I believe there is no more important issue than Medical Freedom. If we cannot choose what we put into our bodies, then we do not have freedom. Period.

Alaskans (and all citizens!) should have the right to make a free, informed choice (without coercion) as to what they chose to put in their bodies. Medical decisions should always be a private conversation between a doctor and a patient - and everyone has a right to refuse invasive medical procedures for any reason.

Many people I know have valid reasons for not choosing to have a vaccination. Some people have already had Covid and have Natural Immunity (which has been shown to be more durable and long-lasting than vaccine immunity), others have a moral or conscientious objection to the procedures that were used to develop the vaccines - in particular the fetal cell lines which were not disclosed at the beginning of the vaccine rollout.

No one should be fired from their job, kicked out of school, or denied access to any public spaces or travel just because they choose to exercise their medical freedom.

Please enter my written testimony into record as I was unable to call in for the hearing. Thank you for holding a hearing on this matter. Alaskans need to be assured they will be treated equally and will not be discriminated against, ridiculed, bullied or refused from an establishment based on vaccination status.

As the pandemic goes on we obtain new information. We now know that while the Biden Administration and the Mayor Austin Quinn Davidson in Anchorage were ridiculing American Citizens and ostracizing the "essential workers" of the pandemic who have gone to work since day one, got COVID-19 and recovered, those COVID-19 survivors were 6x more protected against the Delta Variant than the vaccinated population. These divisive, manipulative comments were harmful and I believe if you were to look at the vaccination status of Alaska's victims of suicide in 2021, you would find a high correlation of unvaccinated in that population in 2021 due to the government's bullying actions and them feeling hopeless. We know of situations where passengers would not sit next to children on airplanes because they were not vaccinated! It's unconscionable and this behavior must stop.

SB-156 will help support the growing population of Alaska resident COVID-19 survivors who were 6x as protected as the vaccinated against the Delta variant and are, to this day, unable to provide "informed consent" for the vaccine, as is required by law. If you would like to know more about this, please ask. I'm happy to share why.

Asking who is vaccinated and who is not vaccinated must cease as it is discriminatory based upon confidential medical conditions. Furthermore, it is an outdated measurement tool still in place in a state where there is no longer an emergency. We now know vaccines do not keep someone from getting the virus, from being contagious with the virus, or from spreading it. In fact, the most recent data shows the vaccinated are more likely to have the virus and be asymptomatic, they replicate the virus more aggressively (produce more of it faster), and they are MORE likely to transmit it to others unknowingly than the unvaccinated.

Please remove the outdated, divisive messaging of "vaccinated" vs "unvaccinated" and correct the record. We do not have a "pandemic of the unvaccinated." What we are emerging from according to the CDC is a pandemic of the obese with 78% of people hospitalized with covid being overweight or obese. We are emerging from a pandemic of the unwell according to the CDC with a vast majority of people dying with covid already having 4 or more comorbidities and being extremely ill before they contracted COVID-19. The CDC is no longer recommending required masking by administrative entities, as of today. We also have an alarming amount of mistrust by the American people of our government officials at this time as a result of not making quick changes as a result of new information contradicting lockdowns and restrictions on the public. It's long past time for that to stop.
