I am testifying in support of SB 156. The practice of discriminating based on vaccine status, especially for a virus for which the vaccines we have available DO NOT STOP, is absolutely asinine.

This issue has affected my family personally, as my oldest son is awaiting separation from the military due to his refusal to be vaccinated. His dream was to serve his country, and after one short year, his dream is being crushed over a vaccine that has done nothing to preserve the readiness of our military. In fact, when he got COVID last month, so did half of his ship. (Note: EVERY other shipmate was vaccinated.) And they all quarantined and they all recovered and got back to work. 
